Vatican City (CNA/EWTN News) - "When we await at home a visit from a loved one, we prepare everything with care and happiness. In the same way we want to prepare ourselves for the coming of the Lord: to wait for him every day with solicitude, to be filled with his grace when he comes," the Pope said Dec. 10.

In his weekly Angelus address, Francis reflected on the first reading from Isaiah, which says to "make straight in the wasteland a highway for our God! Every valley shall be filled in, every mountain and hill shall be made low."

The Pope pointed out that the valleys in this passage can represent our sins of omission, such as failing to pray, or praying very little. The valleys could also be the ways we have failed to have charity toward others, especially those most in need of material or spiritual help.

In Advent, "we are called to be more attentive to the needs of others, those closest (to us). Like John the Baptist, in this way we can open roads of hope in the desert of the dry hearts of many people," he said. Therefore, Advent is a good time to fill these valleys in our life, he said; to pray more intensely, to prioritize your spiritual life.

On the other hand, when the verse says, "every mountain and every hill be lowered," we are reminded of our faults of pride, arrogance and superiority, which must become attitudes of meekness and humility, just like our Savior is "meek and humble of heart." Then, when we've examined our conscience, "we are asked to eliminate all the obstacles we put into our union with the Lord" with joy, he said, because we are preparing for the coming of our Savior.

"The Savior we are waiting for is able to transform our life with the power of the Holy Spirit, with the power of love. Indeed, the Holy Spirit pours into our hearts the love of God, an inexhaustible source of purification, of new life and freedom," Francis said. May the Virgin Mary, he concluded, who prepared for the coming of Christ with her whole being and existence, "help us to follow her example and guide our steps to meet the Lord who is coming."

Kentucky State Council Featured Program Consecration to the Holy Family

To help families live out the joy of Christ, Supreme Chaplain Archbishop William Lori has composed a new prayer through which families may come together to consecrate themselves under the protection of the Holy Family.

Every Knights of Columbus council should invite families of their parish to offer this prayer of Consecration to the Holy Family at all Masses on the first Sunday after Christmas. This day is traditionally celebrated as the feast of the Holy Family. It is our hope that this prayer may strengthen our families and revitalize our parishes.

This is a very simple program to conduct. Follow the following steps to make the prayer program.

Discuss with your pastor the significance of every family offering this prayer of family consecration, and ask his permission to share the Consecration to the Holy Family prayer cards at Masses on the first Sunday after Christmas, or another appropriate Sunday.

Speak to pastors and chaplains on the best way to share how the Holy Family serves as an ideal model for the families of your parish. Some chaplains may simply wish to explain this teaching in their homilies or sermons, while others may wish the council to sponsor a guest speaker to come to the parish.

Order the [Consecration to the Holy Family prayer cards \(#10371\)](#) for distribution at your parish. Order enough cards to share with every family in your parish, and distribute them before Mass.

Recite this prayer together as a parish family on the first Sunday after Christmas, traditionally celebrated as the feast of the Holy Family. Ideally, the celebrant should invite all those present to make the act of consecration together after the closing prayer and just before the final blessing.

Star Councils Awarded

Nearly 2,200 councils earned the Star Council Award, the highest distinction available to a local K of C council, for the 2016-17 fraternal year. These councils, led by the grand knights listed here, conducted the required charitable and fraternal programs in the "Surge ... with Service" areas and also achieved their membership and insurance quotas. Each council will receive an engraved plaque from the Supreme Council in recognition of its accomplishment. Of these councils, 320 earned the Double Star Council Award for meeting 100 percent of their insurance quota, and 200 percent of their membership quota and 239 earned the Triple Star Council Award or higher.

- Numbers in red indicate councils that achieved the Double Star Council Award.
- Numbers in blue indicate councils that achieved the Triple Star Council Award or higher.

Finally, 5,630 councils earned the Columbian Award for excellence in programming; 3,245 attained the Father McGivney Award for meeting their membership quota; and 2,713 earned the Founders' Award for meeting their insurance quota.

Brothers, the calendar year is winding down, and many of us have been recharged from the Mid-Year Meeting in Campbellsville and the great news of our successful year. We had a wonderful exchange of ideas and information from all our attendees about what they are doing that is working, and where they were looking for some help and suggestions. And of course, our host council 12923 in Campbellsville did an exemplary job in welcoming us and handling everything we needed.

While the calendar year is coming to an end, this is just the halfway point in our fraternal year. We need a solid next 6 months in Programs and Membership Recruiting to get us where we need to be. Remember, it's not how you start that matters, it's how you finish and the second half of the year is more important than the first half. Our Membership Chairman, PSD Rick Arnold, has outlined some of the many recruiting incentives available. The most recent is the \$4.50 reduction in Supreme Per Capita (per billable member) for councils who achieve Star Council. **Brothers, this is some serious money for our councils and it costs about \$1 million to do this.** If Supreme is that serious about boosting membership, we need to as well.

The State incentive of \$5 off New Member Billing is coming to an end on the last day of this month. So, if anyone has one or more completed form 100's, or candidates ready to go through the Admission degree-Get this done NOW!

Year over year, our Order continues to break records for Charitable giving and hours of service in our communities. Last year we collectively donated 177.5 Million dollars and over 75 million hours of service work. The average value of 1 service hour is about \$20, so that's over \$1.5 billion in service! As you think about these impressive numbers, look at your fellow Brother Knights and their families and realize that you are all responsible in part for these great accomplishments. Now think about how much more we could do with a few more good men. During this Advent Season, please consider the gift of helping a good catholic man be a great catholic man and let's get a Knight before Christmas!

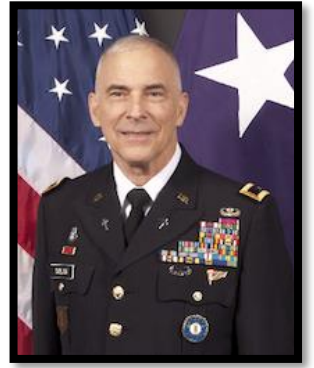

Such defense of all that God made good, and the community who embodied His grace, involved effort and risk—and it still does today, though in different forms.

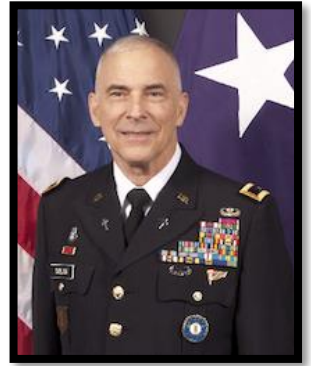
Instead of barbarians or Vikings or Saracens attacking the faithful (though actual battles do still rage in the Middle East and Africa), most attacks contemporary knights face are indifference and bigotry, cloaked as modern or progressive thinking. Defending the not-yet-born can result in one being called a woman-hater. Defending individual religious liberty can result in lawsuits alleging that the Knight is prejudiced; and defending the freedom of discourse in the public forum, just like anyone else, often brings a charge of engaging in hate speech.

The Knightly way, indeed the Christ-like way, of defending against such subtly vicious attacks is not to withdraw from the battlefield, but to press on even harder with the contemporary weapons of legal injunctions, friends of the court briefs, and simple refusal to be intimidated by education officials or government agencies.

However, the ammunition needed to accompany those weapons is the grace of Christ. This grace is as strong as his resolve to go through the way of the cross knowing its conclusion in his sacrificial death necessary to redeem us from our sins, but it is also filled with graciousness in speech and demeanor in the face of insult and even abuse. All of this is accompanied with the wisdom of God to know which battles to engage in at what times and places—so as to win the entire war (for souls) best.

Last month I told you about a homeless man that lives outside a store a few doors down from where I work. And I have an update. I stopped in and talked to him for a little bit shortly after writing the article last month and it turns out that he is quite well adjusted. His name is Tim and he has several people looking in on him. In fact, he even has a miniature Christmas tree next to him. The first thing I did was offer to go buy him some food and he informed me that he was super full and could not eat another bite. And at no time during our conversation did he ask for money or even hint that he was looking for a handout. I told him that it was going to get cold in a few days and asked him if he would like to go to a shelter to stay warm. He told me "I've tried that. They don't want me." I told him it was going to get pretty cold and he pointed out that he has plenty of warm clothes to get him through. He then changed the subject and I didn't push it.

A few days ago I stopped by and spoke with Tim. Again, he was in good spirits and was not hungry or looking for any handouts. I asked him if I could get him to a shelter and he refused again. This time he said "I have something written on my forehead that they don't like." I told him that he could keep his hat on but again he refused. I did not ask him what he was trying to hide, but it is something big for sure.

I will continue to check in on Tim, but I expect that he will want to continue staying put for a while. Please join me in saying a prayer for Tim and all homeless people in hopes that they get the help they need. Matthew Chapter 25, verse 40 "And the king will say to them in reply, 'Amen, I say to you, whatever you did for one of these least brothers of mine, you did for me.'" Please note, I am not suggesting that we give money to homeless people. But, no one deserves to be hungry. I will always be happy to buy someone a meal.

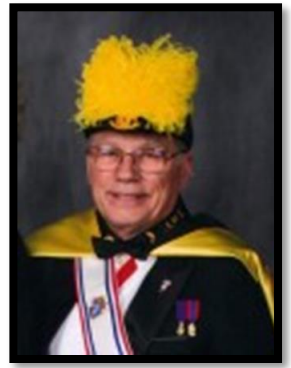

Worthy Faithful Navigators and Ladies,

December Events; President James Monroe introduced his "Monroe Doctrine" during his annual message to the Congress, prohibiting any further colonization of the American continents by European powers, stating, "we should consider any attempt on their part to extend their system to any portion of this hemisphere as dangerous to our peace and safety.

Martin van Buren (1782-1862) the 8th U.S. President was born in Kinderhook, New York. He was the first President who was born a citizen of the United States. He served from March 4, 1837 to March 3, 1841.

George Armstrong Custer was born in New Rumley, Harrison County, Ohio. He graduated from West Point at the bottom of his class in 1861, then became a dashing cavalry officer in the Civil War and fought at Bull Run. He was appointed brigadier general and served gallantly at Gettysburg and in the Virginia campaigns. After the war, he took part in the Western expedition against the Sioux Indians. In June of 1867, Custer and over 200 of his soldiers from the U.S. 7th Cavalry were killed by Sioux warriors at Little Bighorn in Montana.

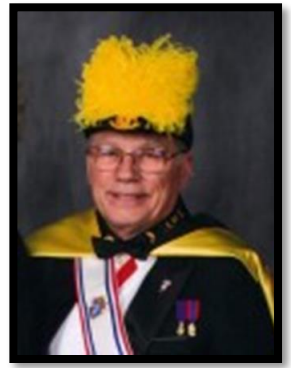
December 7th, 1941, The U.S. Naval base at Pearl Harbor, Hawaii, was attacked by nearly 200 Japanese aircraft in a raid that lasted just over one hour and left nearly 3,000 Americans dead.

December 14, 1799 - George Washington died at Mount Vernon.

Yes, the Supreme Knight, Carl A. Anderson and the Board of Directors, have made some changes. There is a New Fourth Degree Uniform. Tuxedos are optional for Exemplifications, Navy Blue or Black Suits can be worn for the Exemplification. A pin stripe gray suite is acceptable. The current wear out date is now June 30, 2019 for the old Regalia.
