The month of May (<u>Overview</u> - <u>Calendar</u>) is the "month which the piety of the faithful has especially dedicated to Our Blessed Lady," and it is the occasion for a "moving tribute of faith and love which Catholics in every part of the world [pay] to the Queen of Heaven. During this month Christians, both in church and in the privacy of the home, offer up to Mary from their hearts an especially fervent and loving homage of prayer and veneration. In this month, too, the benefits of God's mercy come down to us from her throne in greater abundance" (Paul VI: Encyclical on the <u>Month of May</u>, no. 1).

This Christian custom of dedicating the month of May to the Blessed Virgin arose at the end of the 13th century. In this way, the Church was able to Christianize the secular feasts which were wont to take place at that time. In the 16th century, books appeared and fostered this devotion.

The practice became especially popular among the members of the Jesuit Order — by 1700 it took hold among their students at the Roman College and a bit later it was publicly practiced in the Gesu Church in Rome. From there it spread to the whole Church.

The practice was granted a partial indulgence by Pius VII in 1815 and a plenary indulgence by Pius IX in 1859. With the complete revision of indulgences in 1966 and the decreased emphasis on specific indulgences, it no longer carries an indulgence; however it certainly falls within the category of the First General Grant of Indulgences. (A *partial indulgence* is granted to the faithful who, in the performance of their duties and in bearing the trials of life, raise their mind with humble confidence to God, adding — even if only mentally — some pious invocation.

Council Histories

Sampson Council 15914, Fort Campbell, KY. This Council has the distinction of being the first (and only) military Council in this Jurisdiction. Their Charter presentation was attended by Supreme Knight Carl Anderson and other notables from New Haven. Since Fort Campbell real estate is in both Kentucky and Tennessee there was much discussion about which Jurisdiction would lay claim to the Council. Long story short through a lot of work by then DD Joe Schmitt the Council was ceded to Kentucky. Council 15914's history is attached.

On May 31, 2014, Supreme Knight Carl Anderson led a delegation from the Supreme Council to Fort Campbell, Kentucky, to present the charter to the newly established military council there. Fort Campbell is a U.S. Army Base which straddles the state line between Kentucky and Tennessee. It is the home of the 101st Airborne Division, "the Screaming Eagles."

A Mass with council members was celebrated on post in the Soldiers Chapel, home of the Catholic Chaplaincy, by Father Grant Gaskin, Charter Council Chaplain, at whose request the council was formed.



At the conclusion of Mass, the supreme knight addressed those assembled, reflecting on the ways those who serve in the military help build a civilization of love. "If we understand that the great commandment of love of neighbor is foundational to the Christian life," he said, "and if we are to understand this vocation to love is represented at its highest point by the one who is willing to lay down his life for another, then who better than a soldier to understand the sacrifices necessary for building a civilization of love?"

Council 15914 is named for Father Francis L. Sampson, a renowned military chaplain who served in three wars, eventually attaining the rank of major general. As a chaplain in the elite airborne division, Chaplain Sampson was trained as a parachutist and saw continuous action during World War II. He was among the Allied troops who landed at Normandy on D-Day, June 6, 1944, and was held twice by the Germans as a prisoner of war. He was awarded the Distinguished Service Cross, the nation's second highest military award, for his heroic actions in World War II.



Chaplain Sampson served during the Korean conflict and was an instructor at the Army's chaplaincy school. During the Vietnam War, he was promoted to Deputy Chief of Chaplains in 1966 and the following year was made the Army's Chief of Chaplains. Father Sampson died in 1996. A member of the Knights of Columbus for 55 years, he belonged to Big Sioux Council 5029 in Flandreau, South Dakota.



Known as the "Paratrooper Padre"

As a chaplain in three wars, Sampson was never a reluctant American patriot. For his service, he was awarded the Distinguished Service Cross, Distinguished Service Medal, Bronze Star, Army Commendation Medal with Oak Leaf Cluster, Purple Heart and more than a dozen other military honors. Concluding his remarks, the Supreme Knight called the members of the new council to conduct themselves "in such a fashion that Father Sampson's words may always ring true — that America's military will always embody 'the highest ideals of any man' and that, like Father Sampson, America's Catholic warriors will always provide its proudest examples."



After his remarks, the supreme knight presented the charter to the council's founding Grand Knight, Anthony Carmona, alongside District Deputy Joseph Schmitt. Grand Knight Carmona is a 23-year Army veteran who works for the government in support of the Army at Fort Campbell.

May is upon us and things are hopping! Preparations for the State Convention are at full speed and we are fast the approaching wrap up of the fraternal year. We have 2 months to put the final polish on all the great work that has been done by over 12,000 Brother Knights and their families from across the state.

This year's State Convention begins on Saturday May 19th, and as a reminder, please be sure one of your convention delegates remembers to bring the council's banner (and Pole & Stand) for proud display in the meeting room. Let the other councils from around our state know that you are represented! Please be sure to mark the pole and stands so that you can easily identify your equipment when the convention concludes on Sunday.

At this time every Council should be engaged in their own race to achieve Star Council. There is a significant savings to your council for reaching this through the reduced Supreme Per Capita. The Supreme Knight has authorized the \$4.50 per capita credit for all billable members to all councils that attain one or more levels of the Star Council Award for this Fraternal Year, 2017-2018. We had several councils who took advantage of this last year and I hope that we have more councils will take advantage of this opportunity to earn needed funds.

We have some great news to pass along. As of Monday, May 14, 2018 our jurisdiction has been enrolled in the Knights of Columbus E-MEMBERSHIP program. We have spoken about this several times and most recently at the State Mid-Year in Campbellsville. The program is designed for catholic men who are interested in joining, but are maybe not quite ready or able to go through the initiation. They will be members of the State Council and can convert to a conventional member at any time. To date, 65% of the e-members have converted, so this is an impressive recruiting tool. Please ask your delegates to take special not of the E Membership information that we expect to have at the upcoming State Convention.

I wish I had more time to write something eloquent, inspiring and motivational. But with all the work ahead in the next few days I only have enough time to tell you all how proud I am of what the Knights stand for, and more specifically, all the great things you have accomplished this year. It has been an honor to serve as your State Deputy and I look forward to seeing many of you at the State Convention in Lexington.

Report from the State Chaplain:

Forty years ago this May 27th I was ordained in the cathedral of Louisville by Archbishop Thomas McDonnough (of happy memory). Less than two years before that there were 12 in my class as we began our third year of theology, preparing for diaconate ordination at the end of that school year and priesthood ordination at the end of our fourth year of theology. Only four of those twelve were ordained deacon in '77 and priest in'78. From the little I know, the others remained faithful to their calling as baptized and confirmed members of the mystical body of Christ--and I applaud them for having tried seminary life. Sadly, within nine years the other three classmates with whom I was ordained a priest had left the active ministry and 2 of the 3 have disappeared.

The reason I mention all of this is that we often hear statistics about marriages that have succeeded and ones that have failed. Although priesthood and marriage are both sacraments, we rarely think of them in the parallel ways that they truly are: both are lifetime commitments, both require a lot of maintenance work, and both are a wonderful source of grace for the individuals and the communities they enhance. Both are necessary for the continuing success of the Mystical Body of Christ.

The Knights of Columbus support both marriage and priesthood--for their members and for many others through their programs and instruction booklets. As brother knights, rejoice with me in 40 years of the gifts of God's grace in my life, and rejoice with one another in every marriage which bears fruit for the kingdom of God-generation after generation.

Several years ago, a brother knight, Mike Showalter, came to our council meeting and mentioned that he was trying to put together an area-wide Knights of Columbus Chili Cook-off to raise money for seminarians. This sounded like a good idea to us and we agreed to participate and our council agreed to host the event. We sold tickets after all the Masses for two weeks ahead of time, not only to collect money for the seminarians, but also to raise awareness for the event.

I believe we had 7 councils from the central Kentucky area participate (all thanks to Mike) the first year and it was a huge success. Bishop Gainer celebrated the 4:00 pm Saturday Mass and then we had the Chili Cook-off directly afterwards in the gym. We had approximately 650 people come through and have chili, all for a great cause. Each council brought 10 gallons of their best chili, and we had the priests do the judging. All the money raised from the ticket sales and 50/50 drawings was donated to the Bishop for him to use however he thought best to help the seminarians. This event has become an annual event now.

This was a win-win-win. It was great for the Bishop, it was great for the people that came to eat the chili, and it was a great way to bring the councils together to all work for a unified cause. It was a great example of the second principal of our order, Unity.

I would like to see more of these types of events throughout the state. Not necessarily Chili Cook-offs, but events that bring our councils together to work for a common goal. I know that the councils in Louisville do this for their Clergy Appreciation Dinner every year and it is a great success. And the councils in Covington band together to help put on the Bishop's Seminarian's Ball which is a huge event. There are plenty of other examples of councils working together, I cannot list them all. For the councils that are working together, good job keep up the great work! If you council does not work with other councils, I suggest that you consider partnering with another council and do something together. You don't have to be close to each other to make this happen. For example, the Ashland council could partner with the council from Murray and they could have a friendly competition to see which one could have a bigger food drive for their local food bank. Or they could both collect supplies for care packages for our troops overseas and then meet in the middle at the State Convention to put them together and mail them out. The possibilities are endless.

UPCOMING STATE CONVENTION – Things you should know

Any member of the Knights of Columbus that is in good standing with the Order and that has a valid travel/membership card may attend the State Convention Business meeting.

Only those councils in good standing with Supreme and the State Council may have a voice and vote at the convention. (Article 1 section 9 of the KY State By-laws)

Only those councils having properly submitted their delegate's paper work may have a voice and vote during the convention. In the case of a "Contest of Delegate" one member of each side may appear before the Credentials Committee. (Article 1 section 8 of the KY State By-laws)

A candidate being nominated for office must be nominated by a recognized delegate or a member of the State Council with "Voice" privilege.

A third degree member in good standing can be nominated from the floor, but it will be announced that he does so without a review or recommendation from the Election Committee. (Article III section 2(f) of the KY State By-Laws)

Council Resolutions:

We have a total of 14 Resolutions submitted for review and action at the upcoming State Convention. The Resolution Committee will be composed of the following councils:

1055, 1361, 1418, 1955, 2046, 2282, 3909, 5634, 6897, 10725, 12623, 13196, 14728, 15063, 15484, 15841, 16206, 16232 and 16424

It is the responsibility of the Resolutions Committee to be familiar with the resolutions, bring up any concerns for discussion and be prepared to vote on them at the State Convention. All 14 resolutions were sent out last month to each Council's Grand Knight and to the Past State Deputies. Although I will have a few copies of the resolutions with me at the State Convention, it is my expectation that the members of the Resolution Committee will be fully informed and ready to express any concerns and then vote on each resolution.

Candidacy Declarations:

There are a total of 6 Candidacy Declarations at this time, one for each current State Officer and two new brother knights running for a State Office. Current State Deputy Gabe Cabral has faithfully served his two terms and will not be running for an office this year. An individual wishing to run for a State Office and not having submitted a Declaration for Candidacy may do so at the State Convention during the period of time that the request for additional candidates for a specific office is called out. A candidate for office cannot nominate himself. In order for a candidate's nomination be accepted, the nomination must be presented to the assembly by a certified delegate to the State Council or a member of the State Council having "Voice" privilege.

Safe Environment Training:

There are currently 31 councils that have not completed the required training. In some cases it may be that an individual did not get his "background" check completed, in most cases either the GK or Youth Director or both have not completed their training. All training should have been completed by the end of December, 2018. Successful completion of the Safe Environment Training modules is a requirement for a council to achieve Star Council.

Those councils that have not completed their training have either been called or have received at least one email notice requesting feedback as to when they will complete their training. May Events; May 1, observed as May Day, a holiday and spring festival since ancient times, also observed in socialist countries as a workers' holiday or Labor Day.

World War II General Mark Clark (1896-1984) was born in Madison Barracks, New York. He commanded the U.S. Fifth Army which invaded Italy in September of 1943, fighting a long and brutal campaign against stubborn German opposition.

Pope Leo XIII (1810-1903) was born in Carpino, Italy (as Gioacchino Pecci). He was elected Pope in 1878 at age 67 and lived to govern the church another 25 years, laying the foundation for modernization of Church attitudes toward a rapidly industrializing and changing world.

During his second journey of exploration in the New World, Christopher Columbus discovered Jamaica.

Decoration Day was first observed in the U.S., with the tradition of decorating soldiers' graves from the Civil War with flowers. The observance date was later moved to May 30th and included American graves from World War I and World War II and became better known as Memorial Day. In 1971, Congress moved Memorial Day to the last Monday in May, thus creating a three-day holiday weekend.

On May 7, 1945, in a small red brick schoolhouse in Reims, Germany, General Alfred Jodl signed the unconditional surrender of all German fighting forces thus ending World War II in Europe. Russian, American, British and French ranking officers observed the signing of the document which became effective at one minute past midnight on May 9th. Jodl was then ushered in to see Supreme Allied Commander, General Dwight D. Eisenhower, who curtly asked Jodl if he fully understood the document. Eisenhower then informed Jodl that he would be held personally responsible for any deviation from the terms of the surrender. Jodl was then ushered away.
