EXEMPLIFICATION FEE:

The fee, set by the Supreme Council, for Fourth Degree <u>Candidates and Deacons</u> is \$70.00. The fee includes a social baldric, lapel pin and one banquet ticket (whether you are able to attend the banquet or not). It does not include hotel accommodations. There is no exemplification fee for <u>Priests</u> but it is requested that their Council or Assembly pay for his banquet ticket. This fee does not include the yearly dues payable to your assembly.

LUNCH (optional)

There will be a box lunch available at 11:00 a.m. for the Candidates and Sir Knights. There is a \$10 fee, payable with registration. There will be very few tickets available on the day of the Exemplification. Please reserve your ticket with your registration.

BANQUET TICKETS:

Tickets for the Banquet are \$30 if purchased by August 20. Tickets purchased after that day will be \$45. There will be no Banquet tickets available on the day of the event.

ATTIRE: **REGALIA IS NO LONGER ALLOWED**

<u>Candidates and Sir Knights</u> must wear a Dark Suit (Black or Navy Blue), Plain White Dress Shirt - Button cuff (no French cuffs - no button down collar shirts), Conservative Necktie, Black Socks and plain Black Shoes. The uniform is to be worn as you would a business suit.

<u>Priests and Deacons</u> may wear their clerical attire. <u>Military Candidates</u> may wear their full dress uniform. <u>Police, Firefighters, and Emergency Medical Technician Candidates</u> may wear their dress uniform.

<u>Color Corps and File Leaders</u> must wear the uniform or black tuxedo, black bow tie and cummerbund, plain white pleated front shirt with a lay-down collar (no wing collars, frills or color), black socks and black shoes. When the tuxedo is worn, the social baldric is to be included.

Faithful Navigators, Past Faithful Navigators, Former Masters, Former Vice-Supreme Masters and Color Corps Commanders may wear the uniform (no regalia) of their current, past or former office, including the jewel of their current Council or Assembly office, or Miniature Jewel(s) should be worn.

HONOR GUARD/COLOR CORPS:

Honor Guard and Color Corps will be under the direction of <u>District Marshal Mike Kuchenbrod</u>. **Color Corp Practice** for the Exemplification will take place on Saturday, August 28 at 10:00 a.m. **Sir Knights** possessing Color Corps uniform (no regalia) may dress for the Mass procession. Formation for Dignitaries and new Sir Knights for Mass will be at 3:45 p.m.

HOTEL ACCOMMODATIONS:
