The month of January is dedicated to the <u>Holy Name</u> of Jesus, which is celebrated on January 3. The first twelve days of January fall during the liturgical season known as <u>Christmas</u> which is represented by the liturgical color white — the color of light, a symbol of joy, purity and innocence (absolute or restored). The remaining days of January are the beginning of <u>Ordinary Time</u>, which is represented by the liturgical color green. This symbol of hope is the color of the sprouting seed and arouses in the faithful the hope of reaping the eternal harvest of heaven, especially the hope of a glorious resurrection. It is used in the offices and Masses of Ordinary Time.



Thou shalt call His Name Jesus, for He shall save His people from their sins.

The opening days of January may be cold and nature bleak, but the domestic church still glows warm with the peace and joy of Christmas. We dedicate the New Year to Mary on the January 1st Solemnity honoring her as Mother of God; and on January 7, the Solemnity of Epiphany, we rejoice with her, as her Son is adored by the three Wise Men.

Herald John, who ushered in the Advent season, is present once again to close Christmastide on the feast of the Baptism of Our Lord (The First Luminous Mystery), and to open the Season of Ordinary Time. He points to Jesus, the Lamb of God who unites time and eternity in the Eucharistic Sacrifice, and even January's diminishing darkness seems to echo St. John's prayer: "He must increase and I must decrease."

Incentive n. something that serves to encourage or inspire. Many of you Grand Knights will recruit to grow your Councils without thoughts of any tangible benefits. An incentive is "icing on the cake" and when the criteria is met a pat on the back to those members who worked to earn it. There are many incentives offered by Supreme and the State Council. Supreme offers the McGivney Award (membership), Founders Award (insurance), Columbian Award (program) and all of these rolled into one - the Star Council Award. In addition, there are the International Service Awards presented to at the Supreme Convention to Councils that conducted an outstanding activity in the areas of FAITH, FAMILY, COMMUNITY and LIFE.

The State Council offers four incentives – one for each quarter of the fraternal year. The first two quarters ended on December 31. Seven councils and one district met the requirements for the Fast Lane Challenge, first quarter, incentive: **Councils 11132, 15181, 15211, 15699, 15914, 16179 and 17234 and received \$100.00 checks. District 18 Steve O'Bryan DD received a \$50.00 check.** Seven Councils met the membership requirements for Fast Ride to 75 Challenge, second quarter, and will receive the **\$100.00** incentive. They are **Councils 390, 2046, 10988, 15181, 15699, 16179 and 17234.**

I wanted the following newly announced incentive printed as it was sent out by email on January 7 and 13.

Worthy Grand Knights,

Membership Director Billy Hancock and I have developed an incentive that we think you are really going to like. Here are the details:

Attend the Supreme Convention in Washington, DC as a delegate during the period August 4-6, 2020. Supreme will pay per diem and one-way travel. Unfortunately, there can be only one winner. A winning Council will be chosen through a drawing to be held at the State Convention in May. The winning council will choose a member to serve as the delegate. The delegate's name must be furnished to the State Deputy prior to the end of the Convention. Here is how your Council can get into the drawing:

1 entry - bring 2 members into your council between 1/1/2020 and State Convention 2 entries - bring 3 members into your council between 1/1/2020 and State Convention 3 entries - bring 4 members into your council between 1/1/2020 and State Convention 4 entries - bring 5 members into your council between 1/1/2020 and State Convention

These are "low hanging fruit" for picking. Yet, some of them have been on the list for months. Go after them. Thanks for your dedication to the Kentucky Jurisdiction.

Brothers,

Happy New Year! I hope that 2019 was good for you all. We are a little over half way through the fraternal year now. When I look at all the great work that the councils in Kentucky have done so far this year, I am so proud to be your brother knight. Keep up the great work!

As many of you heard, Supreme has developed a new ceremonial that will bring guys into the order and all the way to 3rd degree in a single ceremony. We had the opportunity to watch the ceremony during the midyear meeting in early December. The feeling of the viewers was mostly positive. There were a few people that voiced their opposition to the new degree and that is ok. The one constant in life is change and change is not always easy.

District Deputy Joe Carter did some research on the subject and posted the following in his district newsletter.

"At the second Supreme Council meeting on May 12, 1883 Supreme Knight James T. Mullen introduced the emblem of the Order.

The first ritual handbook was printed in 1885 but contained only sections teaching Unity and Charity. Supreme Knight Mullen, along with primary ritual author Daniel Colwell, believed that the initiation ceremony should be held in three sections "in accord with the 'Trinity of Virtues, Charity, Unity, and Brotherly love.'" The third section, expounding Fraternity, was officially adopted in 1891.

I'm guessing that back then some knights didn't like the addition of the third degree. Moreover, the third degree took all-day. It was divided into four different sections.

Today, our community is no longer interested in secret organization, nor are they interested in long drawn out ceremonies. They want to spend as much time with their families as possible. The more we involve families in our activities the better. The new ceremony is responsive."

Thanks, Joe for letting me barrow that. Like I said earlier, change is not always easy, but many times it is necessary. And I believe that this new combined ceremony will be good for the councils, the Kentucky Jurisdiction, and the Order as a whole. One of the best parts of this new ceremony is that it is open for our wives and families to see. Men no longer have to leave their families at home so they can join the Knights of Columbus. Supreme has stated that this will be available for the councils to start using on February 1st. You may have some questions, so feel free to contact your district deputy or myself and we will get you the answers.

Because there are those that may want to continue to do things they way they have always been done, As State Deputy, I am authorizing councils to continue to use the "old" separate 1st, 2nd, and 3rd degrees if they would like to. This will continue to be an option until the end of my term on June 30, 2020. After that it will be up to my successor to decide if they want to continue with this option.

Please keep District Deputy John Staudt and his wife Deanna in your prayers. During the storms on the morning of 1/11/2020, their house was struck by lightning and caught fire. The fire department arrived quickly but was unable to save the house. Luckily no one was home at the time and there were no injuries.

I have some good news also. Our newest council in Covington has been officially been instituted. They are Bishop Maes Holy Cross Council #17445. Congratulations go out to District Deputy David White for seeing this through from concept to completion. Great job!

Like I said earlier, we are a little over half way through the fraternal year. And that means we have a little less than 6 months left before the 2019-2020 fraternal year is history. Let's continue to roll up our sleeves, jump in, and finish strong as we charge ahead to make the Kentucky jurisdiction a beacon of light for all others to follow.

2020 RESOLUTIONS

Now is the time for your council to be working on any resolutions you may be considering for submission, review and formal voting at the upcoming Kentucky State Convention in May of 2020.

The Kentucky State Council By-Laws require <u>all</u> resolutions be submitted to the State Advocate by March 15 (copies to the State Deputy and State Secretary) for constitutional review by the State Advocate. Within 10 days the State Advocate will file a report with the State Deputy, State Secretary and the submitting council regarding the legality and constitutionality of the resolution.

The State Advocate must publish the approved resolutions by sending copies to each of the local councils by April 15th and will provide copies of all resolutions to the Executive Secretary in order for him to include them in the State Meeting materials.

At the State Convention, the State Advocate will meet with the delegates assigned to the Resolutions Committee and present all resolutions to them for their recommendations. He will then present the resolutions to all delegates at the business meeting along with the committee's recommendations.

The State Convention delegates will be allowed to discuss each resolution in a reasonable matter and then a vote shall be taken. Resolutions that receive a simple majority of votes will be adopted. Resolutions passed at the State Convention that deal with matters beyond the State Jurisdiction will be submitted to Supreme by June 15 for consideration at the Supreme Convention. The Supreme Secretary will acknowledge receipt of the resolutions and forward them to the Supreme Advocate.

SAFE ENVIRONMENT COMPLIANCE

Please stay vigilant with being Safe Environment Compliant. Compliance must be up to date by May 1st for a Council to be eligible for Star Council recognition or be eligible for a Supreme Program Award. The Council's Safe Environment Status can now be seen when the Officers Online "Reports" tab is chosen and the "Safe Environment Member Status" report is viewed. If you have any questions about Safe Environment status for yourself or your council, let me know.

As of the 1st of January, 2020;

21 Councils in the state are Safe Environment Compliant (19 in October),

16 Councils are close with 3 of the 4 positions compliant (12 in October),

20 Councils have 2 of the 4 positions compliant (21 in October),

26 Councils have 1 of the 4 positions compliant (Same), and

20 Councils have no positions compliant (15 in October).

Please help your Council reach the goal of being Safe Environment training compliant.

IMPORTANT SUBMITTAL OF COUNCIL FORMS

The "Partnership With Special Olympics (#4584)" form is due January 31, 2020. Please fill out if your council had anyone volunteer or the council donated money to Special Olympics.

The "Annual Survey of Fraternal Activity (#1728) for calendar year 2019 is due.

The Semiannual Council Audit Report for period ending December 31, 2019 is due by February 15, 2020.

The Round Table Coordinator form (#2629) should be filled out and sent in if you have not done so.

12 Active Councils still need to fill out and turn in the Form 185-The Report of Officers Chosen for Term. That number was 13 in November.

28 Active Councils still need to fill out and turn in the Form 365-Service Program Personnel Report. That number was 41 in November.

Good Luck to all Free Throw Challenge participants and the Councils who are holding events. I know the kids have been practicing so please support your council for this youth event.

This is going to be a very special Exemplification as Bishop John Stowe will be a part of the Exemplification, Mass, and Banquet! I cannot stress the importance of the Fourth Degree Knights of Columbus making a strong showing to honor Bishop Stowe. Also, February 22nd marks the 120th Anniversary of the First Fourth Degree Exemplification held in New York City in 1900. To commemorate this historic occasion, Candidates will be issued a special certificate at Exemplifications between January 1st and March 31st.

Assemblies should be finalizing recruitment of new Sir Knights and getting their paperwork turned in on time. For help in recruiting, there is a wealth of information at the Supreme website that can be very helpful. Download the flyer at this link

The District Biennial Meeting is coming in either March or April. Faithful Navigators will be notified of the date and location for the meeting in the coming weeks. Per the Fourth Degree Bylaws: *"Faithful Navigator of each Assembly in the District and one delegate for each one hundred members or major fraction thereof of each Assembly which delegates shall be elected by ballot at the February meeting in the year in which such district assembly is convened and after prior notice of the holding of such election has been given to the members by notice or publication. Assemblies shall have the right to elect alternates for the Faithful Navigator and for any delegates to which they may be entitled." Please ensure this most important piece of business is included in your Assembly's February meeting. Any resolutions to be brought before the Supreme Assembly Meeting in August must be brought to the District meeting in accordance with the approved Supreme procedure should be developed and considered now. If you have any questions, please let me know.*

In order to grow the Fourth Degree, we must first grow in the First, Second, and Third Degrees. Recruit new members into your council and advance them through the higher degrees so that they can become Sir Knights in the Fourth Degree. Our councils, parishes, and communities need us Sir Knights more than ever. Let's build up our Army of Knights to fight for what is right and just.
