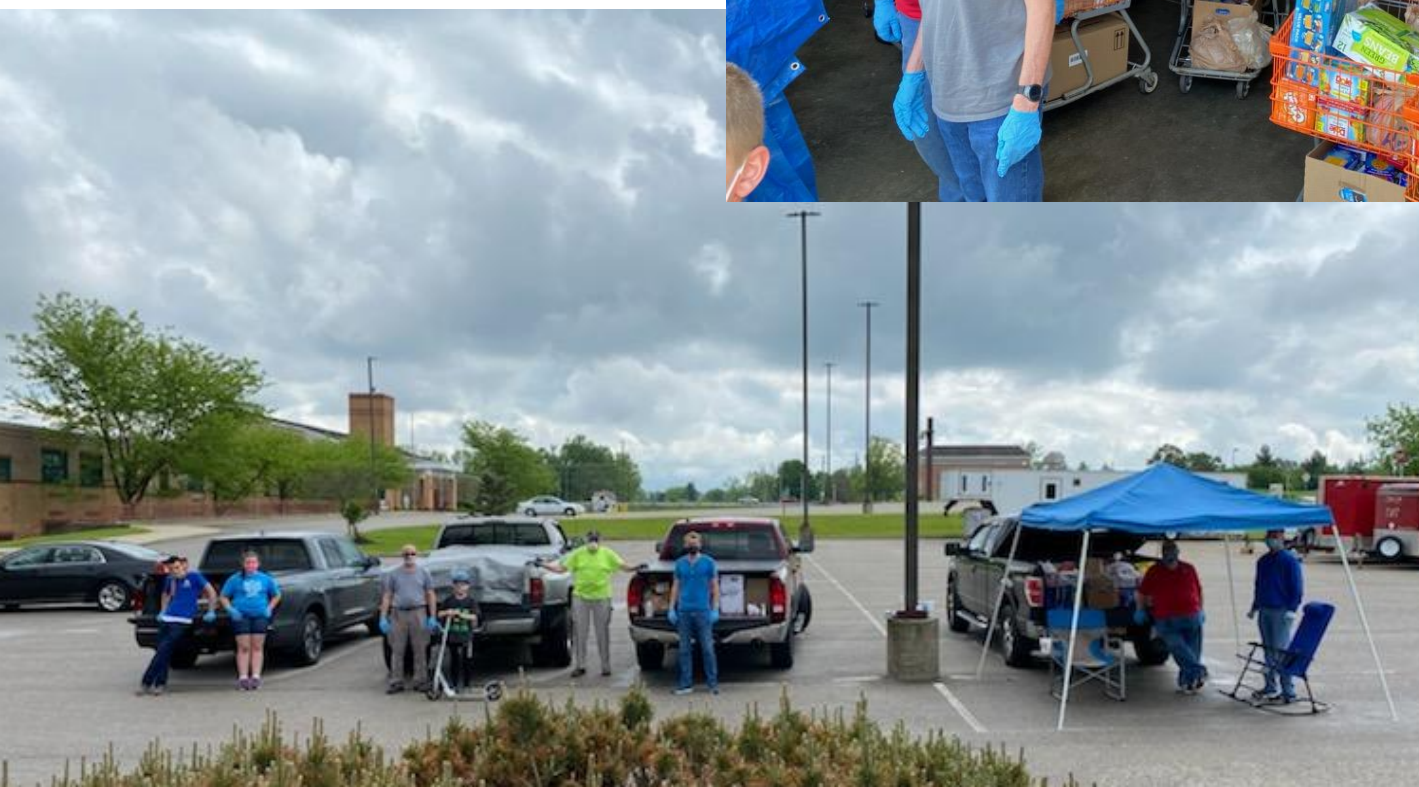

Knights of Columbus have been supporting Special Olympics since the very first International Games in 1968. In Kentucky, Knights have been an important part of the State Summer Games in Richmond for more than 20 years. Unfortunately, this year, COVID-19 has forced Special Olympics Kentucky to cancel the State Summer Games for the first time in its history. But that doesn't mean that Knights aren't still there to help these great athletes.

Special Olympics Kentucky is honoring its athletes and the Games with the "Salute to Summer Games." The Salute is a three-week fundraising campaign that will culminate in a video presentation about the Summer Games that will post to the Special Olympics Kentucky Facebook page and YouTube channel at 6:30 pm on June 5. The Knights figure prominently in both.

Already, Knights have raised or contributed more than \$2,200 to the effort, and all councils have been encouraged by the State Deputy to contribute in some way. Due to the restrictions on gatherings of people that are in place, we were forced to change the format of our state convention this year. After considering several options, Supreme mandated the format that the state councils in USA and Canada would use.

Due to time constraints, I did not deliver the State of the Jurisdiction Address on the state convention call. It will include the reading of an apostolic letter from the Holy Father and the bestowing of the title "Blessed" on Father McGivney. This paves the way for Fr. McGivney to become a saint in the near future.

I would like to congratulate all the state officers for next year. We have a great group of dedicated men ready to continue our tradition of excellence for years to come. I am confident that Steve will do a great job as State Deputy and I hope that you all help him as much as you have helped me during these last two years. The office of State Deputy is a big job and I know Steve is up to the task.

### STATE CONVENTION – my thoughts and opinions

My father use to say “opinions are like butt holes...everybody has one” and I’m certainly no different. In case you missed it, our State Convention was held this past Sunday May 17th, 2020.

- There was no Friday night gathering to get together with friends and brother Knights and their wives.
- There was no early Saturday morning “setting up the meeting hall” activity running back to the hotel room and making a quick wardrobe change.
- There was no reciting the Rosary before the Convention kicked off.
- There was no awards presentation to highlight the council achievements over the past fraternal year.
- There was no Mass where brother Knights and their wives could celebrate their Faith in oneness in Christ.
- There was no banquet where we could break bread together.
- There were no hospitality rooms where we could gather and share a drink and munch on snacks until late in the evening.
- There was no Sunday morning gathering of the delegates, Rosary or in person delegate voting for next year’s State Officers, attendees to the Supreme Convention, Trustees to the serve KAPID and Charities of KY, Inc.

I missed that... In place of all the normal State Convention activities we had a “Virtual State Convention”. Instead what we had was...

State Officers, Screeners and support personnel all logged in early on Sunday morning to the website to make sure we were all connected and that everything was working. We had a robo-call type mechanism that called each of the delegate phone numbers and put them into a queue until it was time to join the meeting. The State Deputy opened the State Convention, our State Chaplin said a prayer, we heard a recording from Supreme Knight Carl Anderson and live comments from Supreme Advocate John Marella. The State Deputy verifying delegate credentials and then moving directly into the election of officers for the next fraternal year. Delegates voting for candidates by pushing a number on their phones to indicate a “yes” or “no” vote or to vote for a specific candidate for State Warden. Delegates were able to speak by pressing \*3 and being screened and placed in a queue until called upon by the State Deputy. We had the State Advocate review the resolutions presented

before the assembly. We had discussion and a vote on Resolution #15 We recited the Prayer to Fr. McGivney and the State Deputy closed the 2020 State Convention and everyone started hanging up.

While the business of the jurisdiction was conducted as required by our Supreme Constitution and By-Laws, as amended by Supreme due to these unprecedented times, it just wasn't the same. State Deputy Cameron Peck did a fantastic job of working with Supreme and the State Officer's in preparing for this most unusual convention. I would like to congratulate State Warden Elect Gary Dykhuis and welcome him as our newest State Officer.

There is one item that occurred during this convention that concerns me greatly. During the discussions surrounding Resolution #15, a comment was made that troubles me. The speaker on the line said he was against the resolution being sent to the Executive Committee for review because he felt that it would not be given due process, meaning in my mind that he didn't "TRUST" the leadership of the KY Jurisdiction. This is very disheartening, yet if he feels this way, how many more do as well. I believe this is a conversation that needs to take place soon rather than later.

The 2020 State Convention has come and gone without much fanfare. Could this be the new norm for future state conventions? I hope not. While it accomplished the goal & requirements imposed upon state jurisdictions to comply with the Supreme Constitution & By-Laws it sure didn't fulfill the "human" aspect of a state convention. It's the "human" aspect, the brotherhood that links us together as brother Knights, that allows us to share our Catholic Faith and to come together in oneness. It's the "human" aspect that enables us to do the many good & charitable works that we do. It's the "human" aspect that allows us to weep & mourn those that we have lost and it's the "human" aspect that allows us to celebrate our successes and accomplishments. Without the "human" aspect of our organization we would be no more than individuals going about our daily lives day in and day out with some sort of direction. The Knights of Columbus, our Catholic faith, our trust in the Holy Family are important elements in living our lives as Christ has shown us.

What the 2021 State Convention will be like is yet to be determined. I feel certain that there will be changes based on this year's convention. Maybe instead of two and a half days things can be reduced to one and a half days. Time will tell.

There are 11 more councils who have one position pending to become fully compliant.

Successful completion of the Safe Environment Training modules for the Grand Knight, Program, Community and Family Directors, along with Background Checks for the Community and Family Directors are a requirement for a council to achieve Star Council and also to be considered for any Supreme award.

### Fraternal Survey #1728 Form

Currently, there are 90 councils that have met this requirement for Star Council this year. Great Job with all the volunteer work and deeds done by your council.

### Service Personnel #365

Currently, there are 74 councils that have met this requirement for Star Council this year.

### Semi Annual Audit #1295

Currently, there are 68 councils who have met this requirement for Star Council

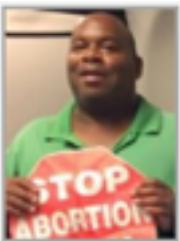

I am working on the calendar for the next fraternal year and will send out the proposed dates to the Assemblies so that everyone can plan early.

I am excited to announce that the Fr. Edward Sorin Province is going to hold an on line Fourth Degree Exemplification on June 27th. This will be very similar to the on line Degrees that have been put on by Supreme in the past few weeks in the first, second, and third degrees. I ask that all Fourth Degree Assemblies get to work now on recruiting Third Degree members into the Fourth Degree in preparation for the on line Exemplification. Information has been sent to the Faithful Navigators. If you are interested in being a part of this landmark event, reach out to your affiliated assembly or to me. This is also an opportunity to save some money as the initiation fee has been reduced to \$50 for this event.

Remember that Assemblies can earn the Star Assembly Award by reaching their membership quota, earning the Civic Award (similar to the Columbian Award), entering the “To Be A Patriot” competition, publishing a monthly newsletter, and submitting the required Supreme reports. If you have any questions, just ask me.

In order to grow the Fourth Degree, we must first grow in the First, Second, and Third Degrees.
