





#### 2021 Salute to Summer Games

When the coronavirus forced the 2020 Special Olympics Kentucky State Summer Games to be cancelled, the Knights of Columbus were asked for their help supporting Special Olympics through one of the most difficult decisions in program history. Knights across the

state responded by raising more than \$6,000 for the Salute to Summer Games. While Special Olympics hopes to hold some form of Summer Games in 2021, with the support of the Worthy State Deputy, the Salute to Summer Games will return as a Knights of Columbus-specific campaign. From early March through the Games, individual Knights and Councils across the state will have an opportunity to raise money to support Special



Olympics with the goal being to add the Knights of Columbus as an official State Summer Games sponsor.

#### Supreme's Family of the Month Program

## State Deputy Steve Zanone

My Brother Knights,

Merry Christmas to everyone! I know this has been a tough year for everyone, but the end of the pandemic is growing closer. We will come out of this stronger and better equipped to thrive as an Order going forward. The injection of technology into our meetings will allow members who would not normally be able to join us to

participate. New opportunities to join online, or to take the degree exemplification online will appeal to a whole new generation of Knights. While it may be hard to see now, there will be some good things to come from 2020. We will survive and thrive. Remember, there is a solution. Go find it!

In case you missed the midyear meeting, I will outline the incentive I have been teasing for the last couple of months for you. Supreme has asked all State Councils to examine per capita relief, and I am proud to tell you your State Council has responded as follows: All councils will receive a 50% reduction in State per capita. In addition, there will be no new member fees assessed. Your council may receive a full elimination of State per capita if you meet these requirements. Be current on ALL forms due by January 15th, 2021. If your council is multiple audits behind, submit the latest one. Don't forget the 990-tax form as well. Also, be Safe Environment compliant. Those are very simple requirements to meet. You should have turned in the forms and completed the Safe Environment training anyway. This will not excuse any payments you owe from last year. We know that many brothers may have trouble paying their dues this year, and it has been difficult to do fundraising activities. Please pay this forward. Help your members who are in need. Leave no neighbor behind.

The highlight of the midyear meeting was that PSD Dannie Harris received the O'Connor Award. Dannie's dedication and service to the Order for many years has earned him membership in a very exclusive group of men. Congratulations to Dannie and thank you for everything you have done for our Order, and what you continue to do. The award was welldeserved.

One thing we ask from all councils is to recruit at least one new member between now and January 15th. The new members can be online members who indicate your council as the council they want to join, or traditional new members. Recruiting can be done, even in the environment we have to work with. Do not give up. Keep looking for the solution. It is there. We have proven recruiting is possible this year. I am proud to welcome the new council in Beaver Dam to our ranks. Congratulations, and I can't wait to see that special beatification charter your council qualified for.

#### **Mid-Year Meeting:**

This year's December Mid-Year meeting was held virtually via Zoom on Saturday Dec 12th. While it wasn't the Mid-Year Meeting that we are used to, it was still a good opportunity to see, for those that had their cameras on, our brother knights from around the

state. The Zoom attendee count showed that there were 97 brother knights on the call at one point representing 53 councils.

Something that I noticed was that there were several councils represented that typically don't or that have been unable to attend our in-person State meetings. I was glad to see them in attendance. Our Supreme Representative Steve Cohen and our General Agent Daniel Schackle were both present for the meeting.

#### **Breaking News:**

Those in attendance saw and heard our Worthy State Deputy announce an automatic 50% reduction for all councils in their State Per Capita billing for 2020 and he offered an additional 50% incentive to those councils that are 100% compliant in their forms submittal (including the 1295 audit report that was due Aug 15th, 2020), Safe Environment Training requirements and have no outstanding monies owed to the State by Jan 15th, 2021. Those councils will receive a 100% reduction in their State Per Capita Billing for 2020.

As State Secretary, it is my responsibility to verify that all councils are current with their New Member and Per Capita billings by Jan 15th, 2021.

State Advocate Dick Burns is responsible for verifying that all councils are Form and Safe Environment compliant by Jan 15th, 2021. Once I receive Dick's report I will begin the Per Capita billing process.

#### Secretary's Report:

The NMB-1 Invoices for the period Jan 1, 2020 thru June 30, 2020 went out around July 27th, 2020 via email. To date I have received payments from all but 3 councils.

There are 4 councils remaining that have not paid their FY 2019-2020 NMB-1 fee & 3 councils that have not paid their NMB-2 fee for FY 2019-2020.

There are 6 councils that have not paid their FY 2019-2020 Per Capita dues. I will make one more effort to contact these councils. If they are still in arrears on Jan 15th, 2021 they will not be eligible for the additional 50% incentive.

#### **Reflections:**

As this most unusual year comes to an end, it's easy to sit back and say "good riddance", and I for one feel that way too. But, upon closer examination I can begin to see the "silver lining" in this "dark" cloud. The pandemic was "man" made not "God" made. Many have turned to prayer and have come to realize that "man" is not in control but only God. Families have been forced to slow down and spend time together. We've come to realize that working from home is a good option for many people and businesses. Yes dining out hasn't been as easy, but now families are sharing the meals together around the kitchen table. We're learning that we can still interact with family and friends via many of the social media apps. Before we slam the door on 2020, let's take a minute and find that "silver lining"!

#### And Lastly:

Let us as Men of faith reach out to our neighbors and offer a kind word. Let us pray to Mary, Queen of Heaven and Earth, and ask for her intercession for peace within our land. #### State Chaplain Update

Brothers, please keep praying for our State Chaplain, Fr. Mario Tizziani. Our prayers are helping him! He continues to improve, but still has a long road in front of him.

Blessed Fr. McGivney, please intercede on his behalf!

#### State Deputy Reveals New Incentive for All Councils!

At the recent Midyear Meeting, SD Steve Zanone shared the details of the new incentive he announced last month. All Councils will get 50% off their State Per Capita assessment next year. Those Council which

- have submitted Forms 185, 365, and 1295 (for the period ending 6/30/20) and
- have completed the Safe Environment Protection Training for the Grand Knight, Program Director, Community Director, and Family Director (28 Councils had already met both those criteria) and
- are paid up on their State assessments (15 Councils were behind at the Mid-Year Meeting) by 1/15/2021 will get the other 50% off!

For a hypothetical council with 100 members, 25 of whom are Honorary Members and 15 of which are Honorary Life members, this comes to \$281.25 and \$562.50 if you meet the criteria. We're making progress, and I appreciate the GKs and DDs who have been working hard during this pandemic period to get those Forms in even though the business of the council may not be proceeding as usual – <u>you can do it</u>, and you don't want to miss out on this incentive!

#### **Recruit! and Retain!**

We're up to 29 (from 20 last month) Councils which have initiated new Brother Knights so far this year, despite the pandemic. 4 (up from 3 last month) Councils have already exceeded their annual new membership quota, led by St. Edward the Confessor Council 15841 in Jeffersontown. We've got until the end of the year for new Online Members to sign up with no dues for their first year (Code: MCGIVENY 2020)!

#### Just Do It!

Our State Deputy Steve Zanone put it succinctly – councils are finding a way to grow and do the work of the Order serving their members and their parishes. His marching orders – **FIND A WAY**! Whatever works best for your council.

Feel free to ask your District Deputy, the State Officers, Field Agent, or our Regional Growth Director for assistance in recruiting!

If each Knight asks 4 men a year to join the Order, and only one of them says "yes", you'll still double the size of your council. If you don't ask, you don't grow. Be sure to use the new eMembership as a tool to get men to take the first step toward full membership.

Worthy Brothers all,

This is really a special time as we approach the end of the year and our thoughts turn to themes of "Peace on Earth" and "Goodwill to Men!"

We think of our Savior's birth in Bethlehem and the beginning of this chapter of salvation history. Many of us will be scurrying around buying a Christmas tree, getting it decorated; looking for that perfect gift for our spouse, our kids and maybe grandkids. There are parties and school Christmas shows. There is a lot going on and you're busier than ever.

But let me ask you to slow down for just a few minutes and consider some financial issues that come up at the end of the calendar year.

1. Because we're so late in the year, you may have met your individual or family deductible on your health insurance plan. Financially this may be the opportune time for some minor procedure to be scheduled; or that visit to a specialist you may have put off. The same is true about dental insurance and sometimes even for vision coverage.

2. Speaking of health insurance, do you have a Health Savings Account? Do you have to spend the money that's in there by year end? Some plans have a "use it or lose it" feature. Do you have to make a decision about how much to contribute next year? These are a couple of time sensitive issues.

3. If you have earned income for the year, what amount will you want to contribute to your traditional IRA, Roth IRA or 401k? Are you eligible to contribute much more based on the "catch up" provision? You won't have to make that contribution until you pay your taxes and that could be four months away; however now is the time to start making plans.

4. Speaking of IRAs, have you received your required minimum distribution for this year? If not, the Internal Revenue Service penalty is a hefty 50% of the amount you should have received!


5. Speaking of distributions, if you or your family has faced hardships due to COVID-19 have you investigated taking the one-time distribution allowed without penalty this year? It could be available to you even if you're not yet 59 ½ years old.

All of these issues come with lots of rules and regulations, so I don't ever want to give any blanket advice. But if you do have questions on any of these issues, please grab me after the meeting. I'd be happy to discuss them with you.

As we prepare to celebrate Christmas, let us be thankful for all the graces God has showered on us, especially the gift of his Son, our Savior!
