## Election of a new Supreme Knight

The Knights of Columbus Board of Directors elected Patrick E. Kelly as the next Supreme Knight on Feb. 5, to continue the mission of charity, unity and fraternity established by the Order's Founder, Blessed Michael McGivney, almost 140 years ago.

Carl A. Anderson will retire February 28, after more than 20 years of service as Supreme Knight and upon reaching the mandatory retirement age of 70. He leaves a

legacy of Christian witness and service to the Catholic Church, to the Knights of Columbus and to communities throughout the world.



Patrick Kelly's tenure as the Order's 14th Supreme Knight will commence March 1.

Mr. Kelly's election as Supreme Knight follows a distinguished career in the Knights of Columbus, the military and public service. For more than 25 years, he has a demonstrated track record of service to Church and country, which will serve him well in advancing the Knights' mission of Charity, Unity, Fraternity, and Patriotism.

Mr. Kelly has served as Deputy Supreme Knight since 2017. Prior to that, he served as Vice President for Public Policy for 11 years, spearheading the Knights' interaction with the White House, Congress and federal agencies. He has also served as State Deputy in the District of Columbia. As a longtime executive and fraternal leader of the Knights of Columbus, he has consistently strengthened its record of charity, advocacy, insurance, investment and membership growth.

Mr. Kelly served as the first executive director of the Saint John Paul II National Shrine in Washington, D.C., and oversaw the renewal of the facility after its purchase by the Knights

in 2011. During his tenure, the shrine became a leading pilgrimage site and a source of education and inspiration for Catholics throughout the United States and the world. Prior to his leadership roles in the Knights, Mr. Kelly pursued a lengthy career of public service. Most notably, he was Senior Advisor to the Ambassador-at-Large for International Religious Freedom at the State Department from 2005 to 2006. His responsibilities included serving as the Department's principal liaison with the Holy See and assisting with the formulation of U.S. foreign policy on religious freedom worldwide. He led U.S. delegations to the World Summit on Islamic-Christian dialogue (2005), the UN conference on interfaith cooperation (2005), and annual Sant'Egidio conferences. He has also held advisory roles on the House Intelligence Committee and the Department of Justice, where he specialized in counterterrorism and national security.

Mr. Kelly served in the United States Navy for 24 years, on land and sea and on active duty and reserve status. As a Judge Advocate General, he specialized in international and operational law and served as the Commanding Officer of the international law unit at the U.S. Naval War College. He served on the staff of the Deputy Chief of Naval Operations and aboard the USS Guam as the Staff Judge Advocate for Amphibious Squadron Two. His personal awards include three Navy Achievement Medals, five Navy Commendation Medals and the Meritorious Service Medal. He retired from the JAG Corps Reserve in 2016.

Mr. Kelly has served as consultant to three committees of the U.S. Conference of Catholic Bishops (USCCB) for more than a decade: The Committee on Pro-life Activities, the Committee on Religious Liberty, and the Subcommittee for the Promotion and Defense of Marriage.

Mr. Kelly has been the Chairman of the Board of Directors of the March for Life since 2012. Under his leadership, the March for Life has become one of the most effective pro-life organizations in the world. He has also been a member of the Board of Directors of the National Catholic Bioethics Center (NCBC) since 2013. He has helped guide the NCBC in its mission to promote respect for the dignity of each human being through an understanding of how the moral teachings of the Church apply in health care and the life sciences.

Mr. Kelly holds a master's degree in theology from the Pontifical John Paul II Institute for Studies on Marriage and Family at The Catholic University of America, a law degree from Marquette University Law School and a bachelor's degree in economics from Marquette University, where he joined the Knights of Columbus in 1983.

He and his wife, Vanessa, have three daughters. They live in Connecticut.

## 2021 Salute to Summer Games

When the coronavirus forced the 2020 Special Olympics Kentucky State Summer Games to be cancelled, the Knights of Columbus were asked for their help supporting Special Olympics through one of the most difficult decisions in program history. Knights across the state responded by raising more than \$6,000 for the Salute to Summer Games. While Special Olympics hopes to hold some form of Summer Games in 2021, with the support of

## A Reflection on the Emblem of the Order

I recently watched a quiz program on TV in which the contestants were shown logos of various products and they had to identify the product. This led me to think about how symbols, emblems, and various logos represent many things. Logos that first came to my mind were the NBC peacock, the CBS eye, the Coke label and polar bear, and the Knights of Columbus emblem.



The Knights of Columbus Emblem of the Order is in many places - on our lapel pins, in this newsletter, on the outside of some of our meeting places, the walls, and on various flags and pennants. This emblem is reserved for the exclusive use of Knights who are practicing Catholic members and who have completed at least the First Degree. But what does this emblem represent?

The Emblem of the Order dates from the second Supreme Council meeting on May 12, 1883.

Look at the emblem carefully. A quick glance indicates there is a shield mounted upon the Formee Cross. The shield is associated with a medieval Knight. The Formee Cross is the representation of a traditionally artistic design of the Cross of Christ thus representing the Catholic spirit of the Order.

Mounted on the shield are three objects:

The fasces standing vertically – in the Roman days the fasces was symbolic of authority which must exist in any tightly-bound and efficiently run organization.

Behind the fasces is an anchor. The anchor is a mariner's symbol for Columbus, the patron of our Order.

Also behind the fasces is a dagger or short sword, the weapon of the knight on an errand of mercy.

Thus, our shield that each Council displays expresses Catholic Knighthood through our organized merciful actions and with the letters K of C, it proclaims our charitable and merciful activities as Knights.

### Secretary's Report:

For those councils that did not qualify for the 100% 2020 State Per Capita forgiveness, please note that the 50% 2020 State Per Capita invoices were emailed out between January 30th and February 4th, 2021. I have already received a number of checks. Thank you to those councils that have already paid.

I am sure that over the next several weeks that I will continue to receive more checks. Please note that all State Per Capita invoices should be paid by April 20th, 2021 in order for your council to have a vote at the upcoming State Convention in May.

### Past due billing Status:

The NMB-1 Invoices for the period Jan 1, 2020 thru June 30, 2020 went out around July 27th, 2020 via email. To date I have received payments from all but 1 council. This council will not have voting rights at the upcoming State Convention until this past due bill is paid. There are 0 councils remaining that have not paid their FY 2019-2020 NMB-1 fee. Thank you!

There are 4 councils that have not paid their FY 2019-2020 Per Capita dues. The councils are: 10987, 12623, 15063 & 15707. These councils will not have voting rights at the upcoming State Convention until this past due bill is paid, even if they are current on their 2020 Per Capita billing.

### 2021 Resolutions

I have sent a letter to all GKs reminding them that councils have until March 15th to submit resolutions for the 2021 State Convention. At the Convention, the delegates assigned to the Resolution Committee will review them and make recommendations to all the Delegates at the Business Meeting. Each Resolution will be open for discussion and voted upon. Those Resolutions that deal with matters beyond our Jurisdiction will be submitted to the Supreme Advocate for consideration at the Supreme Convention. Last year, Council #2282 presented a Resolution supporting a "Paid for Life Dues" program that the Board of Directors took under consideration for further discussion. We'll see if we hear anything about it at next year's Supreme Convention.

### Recruit! and Retain!

We're more than halfway through the Fraternal Year, and only 36 of our 97 active Councils have recruited new members so far. 6 Councils have already met or exceeded their annual new membership quota, despite the pandemic. You can, too!

Be sure to use the new eMembership as a tool to get men to take the first step toward full membership. And remember that free first year dues have been extended through June by Supreme – use promo code McGivney 2020!

If each Knight asks 4 men a year to join the Order, and only one of them says “yes”, you’ll still double the size of your council. If you don’t ask, you don’t grow.

# History Report Billy Hancock PSD

## My Brother Knights

We meet in a see that once encompassed much of America's heartland. The Archdiocese of Louisville, originally the Diocese of Bardstown, once covered the states of Indiana, Ohio, Kentucky and most of Tennessee. The Louisville see truly is the mother church of the American Midwest.

Perhaps the first Mass on Kentucky soil was offered by Father Jacques Marquette in 1673 as he made his way down the Mississippi River on his historic exploration.

The first permanent priest in the state was Father Charles Whelan who journeyed there in the late 1780s to serve a colony of Catholics who had migrated from Maryland. But he stayed only three years.

The generally recognized apostle of Kentucky was Father Stephen Badin, a native of Orleans, France, who was a seminarian when the French revolution struck. He escaped the anti-religious reign of terror by journeying across the Atlantic and became the first priest ordained in the United States. He was given Holy Orders by Bishop John Carroll of Baltimore in May 1793. He immediately was appointed vicar general of the Old West, which included Kentucky, Ohio, Indiana, Illinois, Michigan and Tennessee. He spent most of his time in Kentucky and for many years was the only priest serving the scattered Catholics in that state.

Another pioneer priest in Kentucky was Father Charles Nerinckx, a Belgian who for a time carried on a clandestine ministry during the French revolution and then joined Father Badin in 1805. An indefatigable man, Father Nerinckx built 10 churches in 10 years and founded the Sisters of Loretto, the first native American community.

It is these and many other pioneers we honor by our gathering in Louisville and in the state of Kentucky. We hope to be inspired by their example. We aspire to imitate their zeal in the apostolate.

The preamble of the Kentucky Constitution expresses gratefulness to Almighty God. We join in that gratitude for the blessings God has granted this state and for the multitude of kindnesses He has bestowed on our order as we begin our centennial year.
