

#### **2021 State Convention**

On May 15th the State Convention was held at the Clarion Hotel in Lexington. Due to COVID restrictions, the official business meeting was held during an abbreviated meeting that included virtual participants along with the people that were in person at the hotel.

State Deputy, Steve Zanone did a good job of adapting to the ever changing guidelines and restrictions and we had a convention that was closer to normal than many states had this year.

We had a very special honor this year. Our General Agent, Dan Schachle brought a 1st degree relic of Blessed Father McGivney and placed it in the meeting room for anyone who wanted to see it. The Schachle Family received the relic from Supreme. You can read the story of how Fr. McGivney healed Dan's son Mikey <u>here</u>.

The morning session consisted of the State of the Jurisdiction Address, the reading of the Necrology, and other usual business. The afternoon session was the "meat and potatoes" of the convention. An address from the Supreme Knight, Election of officers and consideration of resolutions were the main business. All resolutions were adopted and all the state officers were re-elected for a second term. The resolutions that were adopted can be seen <u>here</u>.

The awards ceremony that normally takes place on Saturday afternoon was rescheduled for the Organizational Meeting that will take place on July 17-18.

Mass was held in the usual manner and Fr. John List celebrated his first KofC Mass as our new State Chaplain. And he did a great job.

The banquet was well attended and it was a nice opportunity to break bread with brother knights and their wives for the first time in over a year for many people. At the banquet, Fr. List introduced himself, giving a synopsis of how he went from a child

I can remember the moment that my mom and dad told me that she had cancer. It was a scary time in my life, but I can remember praying and praying to God to help my mom get better. I don't tend to really worry about much in life, so this worry was not something I was used to feeling. Yet, thanks to my Catholic education I knew I had to turn to God.

Cancer is not something I really ever thought much about. I had heard people talk about it, but it had never effected me personally. It was a big shock! The first thing that I thought of was that my mom was going to die. I couldn't imagine losing my mom. However, after I thought about it and talked to my parents I knew I had to pray to God. I realized that the only way to get through it all was with the help of God.

Every day I prayed for my mom. She was put on prayer lists at churches and I knew that I was not the only one praying for her. She went to lots of doctor appointments and even had surgery and radiation. I didn't always understand what was going on, but I just kept believing that God was going to help my mom. My faith was what helped me keep living my life like other twelve year old boys.

My mom got through all the doctor appointments, surgery, and radiation. I was so happy to have my mom back to normal. I knew God had answered my prayers. My whole family was very happy. Then one day my mom and dad came home and told me and my brother and sister that my mom had cancer again. I couldn't believe it! I had prayed so hard, and I thought God had answered my prayers.

This is where some people would have given up, but not my family. My mom went back for more surgery and more doctor appointments, and I went back to praying really hard. I knew that if God answered my prayers the first time, he could do it again. In the Bible Peter writes, "Though you have not seen him, you love him; and even though you do not see him now, you believe in him and are filled with an inexpressable and glorious joy." I used that blind faith to get me through another round of cancer treatments.

My mom is now cancer free. I know there are alot of doctors that helped cure my mom, but I also know God had the biggest hand in it all. Whatever the future brings, God will watch over me and my family. I know this, I believe this, and I trust in this. No matter what you go through in life, you should always pray to God. He will always be there!

#### 2020-2021 Catholic Citizenship Essay

Have you ever had that one person that you wish just left you alone for at least 2 hours? How about your sibling? It'd be nice if they would just leave you alone, but what if something bad happened to them? What would you do then? Would you be glad or would you be scared for them?

On February 7th, 2019, I heard that my sister had been trampled by a cow. She had 7 broken ribs and a punctured lung. She also had other injuries, like scratches and lots of bruises. It was very hard being told that something bad had happened to my sister. It was very scary having to wait on her to get to the hospital and not even knowing what had really happened to her. When she finally arrived at the hospital, I had never seen her in the condition she was there. Hearing everything that the doctors were saying, was very frightening.

I didn't stay at the hospital. The doctors said that she needed to be taken somewhere else for her injuries. I went home to pack, to stay with other family members, and I worried about my sister the whole time. I watched her leave in the ambulance and didn't get to see her for another three days. I got many pictures of her, but it just didn't look like my sister.

It was a big change for me. It was late nights, worrying about her during school, having a lot of people ask me about her (or even think I was her and would ask me how I was doing), and being at other people's houses felt weird. It was the last three days of Catholic Schools Week, because they had been snowed out the week before, and I think it was the first time ever that my mom wasn't there with me. My mom teaches at St. Romuald Interparochial school. She had always been there with me during Catholic Schools Week, until my sister's accident, which felt very awkward. It was really hard not to worry about my sister while she was in surgery and I wasn't near her. I didn't know what all was going on.

I prayed a lot during the time she was hurt. I started praying when I heard she had been hurt. I could not wait that Friday when I finally went to see her after I hadn't for three days. My dad and I went to early Mass on Sunday so we could then go back to the hospital to see her. When she finally got home, I was so happy she was back. It was very tiring those 6 days that she was in the hospital. When she got out of the hospital, she still had to go for check-ups. It was amazing to hear that she was completely healed. I am very thankful that she is healed and okay. If that cow went a few inches from where it landed, my sister may not be here right now. I thank God everyday that my sister is safe and doing well.

#### **11th Grade Winner - Ashley Higdon**

Without God, I wouldn't be where I am today. As a Christian person who has been a member of St. Leo Church in Versailles, Kentucky from birth, and was fortunate enough to attend St. Leo School from kindergarten through eighth grade, I have been luckier than most. I have, however, also experienced incredibly trying times in my life that shook my faith. I can completely say that the phrase "God works in mysterious ways" is completely accurate. I can say this because, from a young age, my life was turned upside down, but I am now a stronger person with a deeper faith and a better person because of this trial.

When I think of my childhood, I get this feeling of peace and warmth. My childhood was golden, I had church, family, friends, and loving pets. I didn't have any worries or concerns. I loved going to Bible School, Church, and St. Leo School. The summer before the fourth grade, my Father was diagnosed with brain cancer. I also found out that my Dad was the one in a million to de diagnosed with brain cancer. I remember wondering why God wanted my Father to have this cancer, but at the time, I didn't fully understand what it was or exactly how it would impact my family. During my fourth grade year, I acted as if things were normal, and I tried my best to not think about my family's problems. I prayed with my family at mealtime and tried to help my parents whenever possible, but I couldn't avoid these concerns forever. In less than one year's time, my Mother was also diagnosed with cancer. Suddenly, the same flood of emotions came running through me all over again. I felt angry, sad, hurt, and confused all at the same time. I also knew this time, I couldn't avoid my emotions and overwhelming thoughts. I prayed every night that my parents would be okay and that God would heal them.

As of now, I know that God heard every word and answered my prayers. My Dad was blessed to become a part of an important study for brain cancer which gave him the best possible treatment at the time. Before he went through a very long brain surgery, followed by Radiation, and Chemotherapy treatments six weeks after the operation, he received the Annointing of the Sick Sacriment. Even with all these treatments, my Father was able to keep his memory of his family and not need physical therapy. To this day, my Dad's brain cancer is considered dormant and hasn't grown anymore. He still goes every three months to get his MRI, and he is able to continue with his everyday life.

As for my Mother, prayers were answered when her breast cancer was found to be at stage zero. The doctors very rarely find breast cancer this early. My Mother also received the Annointing of the Sick and went through several surgeries. As a result, she did not need to undergo chemotherapy or radiation. We are so thankful that she doesn't have to worry about getting breast cancer anymore and has helped many other women fight similiar issues. My family was blessed, God saved my parents.

These difficult times have made me the person I am today. God gave me strength and hope to endure the trials of both of my parents being diagnosed with cancer. He was with me and my faith has become even stronger due to these trials. I was so fortunate to be able to continue to grow up with both of my parents, and I am incredibly thankful. "For I know the plans I have for you," declares the Lord, "plans to prosper you and not to harm you, plans to give you hope and a future."(Jer 29:11) At the time, I didn't understand why my parents were diagnosed with cancer, but I now fully understand that it was all part of God's plan. By God giving me these trials, at an early age, he forced me to "wake up" and understand we are all here because of God's love for us. God sent his only Son, Jesus, to die for each of us on the cross so that we could go to Heaven to be with him, and we owe it to Him to believe, trust, and serve Him.

For anyone that was not able to attend State Convention on May 15th where I addressed the State Delegation, here is the gist of what I reported out for the Fourth Degree for the current fraternal year.

The following Assemblies are to be congratulated for already meeting their intake quotas! The Supreme Assembly lowered quotas by 20% in the same manner as councils, which allowed to more Assemblies to reach their goal. In total, 17 of 27 Assemblies met or exceeded their quota! This is an amazing 63%! (The list of Assemblies is at the end of this article.)

As a result of so many Assemblies doing so well, the Kentucky District has exceeded its quota of 156 new Sir Knights with a total of 203 putting us at 130%! The Fr. Edward Sorin Province (KY, IN, WV) exceeded its quota, recruiting 581 of the 549 required or 106% of quota. Sir Knights from Kentucky are to be congratulated on a job well done for this fraternal year. It is apparent with the pandemic, the online Exemplifications were exactly what we needed. As we move forward into the new fraternal year, the online Exemplifications will remain a part of the schedule as we also return to include in person Exemplifications.

Milestones achieved for the fraternal year include St. Vincent Assembly #1576 in Henderson celebrating their 50 Year Anniversary, Fr. George P. Boehmicke Assembly #2753 in Hopkinsville being reactivated, and Archangel Assembly # 3877 in Louisville becoming Kentucky's Newest Assembly! Congratulations to everyone who helped

achieve these milestones, especially Faithful Navigators Tom O'Hagan of Hopkinsville, and Jim Brian of Louisville.



#### **Protecting Your Greatest Asset**

Spring is here, we have a new season and after a blessed Easter it's time to start planning again. With spring and the break in the weather, I've started to put together my honey-do list that will take



me outside into the sunshine. I don't know about you, but this time of year seems to energize me. After being cooped up all winter, and this year really being cooped up, I've been able to think of all the things I need to get done.

Now when you get outside to get that work done, please, please be careful! I'm reminded of two acquaintances who were recently up on ladders. In both cases, the ladder slipped, and each gentleman sustained two broken arms! Out of commission for quite a while. But there are many hazards that can put you out of commission...and that brings me to the important part of my message this month. Protecting your greatest asset!

Your greatest asset is your ability to work and earn an income! Take your annual income (probably fresh in your mind with tax filing day extended into May) and multiply it times your remaining years of working. A 35-year-old male making \$50,000 a year will earn \$1.5 million in the next 30 years... if he never gets another raise! So, you have lots to protect. But what if you're sick or hurt and can't work. Maybe it's something simple like the gents above...a set of broken arms.

Disability does not discriminate; man or woman; black, white, Hispanic, or Asian; young or old. A 2014 CDA Long-Term Disability Claims Review had a number of notes: More than 1 in 4 of today's 20 year-olds will become disabled before they retire, 76% of us live paycheck to paycheck; less than 5% of all disabling accidents and illnesses are work related. That means 95% of those are not covered by Worker's Compensation. You're on your own 95% of the time. Turn to Social Security; but Social Security's report on SSDI says that only about 40% of applicants are awarded benefits. Couple that with 69% of the

private sector workforce having no long-term disability income insurance and it's no wonder disabilities are the #1 cause of mortgage foreclosures.

#### PAST AND FORMER MINIATURE MEDALS THIRD AND FOURTH DEGREE COMBINATIONS



The miniature medals were approved by the board of directors on April 19, 1993 to allow those who have served the Knights of Columbus in a position of authority to wear the medal that acknowledges their contribution, while at the same time giving due and proper respect to the current officers. The medal representing the highest-ranking office is positioned nearest the heart of the wearer. Any neck medal from any source for past state deputy, former district deputy, past grand knight, past faithful navigator, color corps commander or color corps is not authorized. Members entitled to wear more than one

miniature medal should purchase and utilize ribbon bars available from <u>knightsgear.com</u>

The above are examples of the order of precedence of the miniature medals, which always has the highest-ranking medal closest to the heart of the wearer. The priority of the past and former miniature medals from highest to lowest is: Former Supreme Director (not shown) Past State Deputy Former Vice Supreme Master Former District Master Former District Deputy Past Grand Knight Past Faithful Navigator

The miniature medals are to be worn so that the bottom of the medal is just above the name badge when in the pocket. The miniature medal is not to be worn on the jacket lapel.

Display your contributions to the order by wear of the miniature medals you have earned. Know the difference between the term "past" and "former"? Past = elected position while former = appointed position.
