




On Jan 15, our District Deputy, Joe Carter, held judging for District 14. Two of our three entrants, won their age group and now go on to state.

2023 Salute to Summer Games

The Knights of Columbus Salute to Summer Games is back for a fourth year! Once again, with the support of the State Deputy, the Salute to Summer Games has returned as a Knights of Columbus-specific campaign. From now through the 2023 State Summer Games (scheduled for June 2-4 at Eastern Kentucky University), individual Knights and Councils across the state will have an opportunity to raise money to support Special Olympics with the goal being to add the Knights of Columbus as an official State Summer Games sponsor.

The Salute web site (<u>sokysalute.com</u>) will go live on or before March 15. Worthy Grand Knights should have received an e-mail from the State Deputy that outlines a plan for success:

- 1. Identify one or more volunteers to participate
- 2. Set up a team for your Council at sokysalute.com
- 3. Have your participants register as part of your team
- 4. Have participants connect their Salute pages to their Facebook pages

Special Olympics Holds three regional tournaments and a State Tournament in February and March and all four events provide multiple volunteer opportunities for both individuals and groups. Volunteer slots include scoreboard operators, timers and scorebook keepers (some experience helps for scorebook keepers). We are also always looking for trained basketball officials who are willing to help out. Regionals are one-day events, and the State Tournament covers two-days. With multiple courts operating at each of the events, as many as 16 score table volunteers are needed at a time.



ARCHDIOCESE OF LOUISVILLE 2023 WALK FOR LIFE

Despite the day's frigid cold, several Knights and their family members, along with nearly 50 other people gathered in downtown Louisville to pray about human life — on the sin of racism, abolition of the death penalty, the end of abortion, the protection of conscience rights in health care and the protection of human life at its beginning.



WALK FOR LIFE CONT.

The annual Archdiocese of Louisville Walk for Life, held in solidarity with the national March for Life in Washington, D.C., covered 1.5 miles and included five stops for prayer. Karl Dolson, director of the Archdiocese of Louisville's Youth and Young Adult Office, led the walk from the Cathedral of the Assumption to stops at Jefferson Square Park, the EMW Women's Surgical Center, the park at Hospital Curve, and the Thomas Merton Epiphany site near Fourth Street Live. While walking, participants prayed the rosary. During the stop at the EMW Women's Surgical Center, which was one of two places that performed abortions in Kentucky until Roe v. Wade was overturned in June, Dolson asked that they pray for "reparations for the lives that were lost (to abortion) and pray in thanksgiving for all the lives saved." Although abortion is no longer legal in Kentucky, the ban is being challenged in court so it is important to continue working toward a solution for all pro-life causes. Among them, he said, were capital punishment, racism and assisted suicide.

Many walkers wore KofC signs that read "LOVE LIFE, CHOOSE LIFE" and "AMA LA VIDA, ELIGE LA VIDA".





STATE DEPUTY TOM JOHNSON

Brother's we are on the downhill side of the Fraternal Year with an **UPHILL** battle. Seven months have past with 5 months to go. So where do we stand...

Membership – 182 members against a target of 420 or 43.33%

Under 50 intake - 72 against a target of 110 or 65.45%

Online Membership – 100 against a target of 167 or 59.88%

Founders Award – This one is a puzzle because Supreme is reporting 2 against a target of 45. I have a hard time believing that only 2 councils have been credited for attending a Fraternal Benefit Night.

Faith Formation – 2 against a target of 3. This will be completed at the upcoming State Convention.

New Council Development – 2 against a target of 2, plus we have the potential for at least one more this fraternal year.

Membership Drives – 14 against a target of 68. While I feel that number should be higher, without a form 450 it's difficult to tell.

JOHNSON CONT.

Council Engagement or rather Every Council recruiting at least 1 member – 50 against a target of 81 or 61.73%. If the other 40 councils recruited one member, we would be right on track.

Charitable Giving - \$812,660 against a target of \$989,703 or 82.11%. We have a good shot at making this goal.

Volunteer Hours – 63,967 against a target of 230,581 or 27.74%. Not all form 1728's are reported but I feel that councils are not recording all of the great efforts that KofC members do.

1728 Reporting – 26 against a target of 81 or 32.10%

Round Tables - 10 against a target of 6 or 166.67%

Safe Environment Compliant – 28 against a target of 36 or 77.78%. This is such a critical yet simply target to meet that the real target should 100 percent of all active councils. 36 represents a third of our active councils. We must do better!

Your councils should be gearing up for all the upcoming activities over the next several months.

These are just a few that quickly come to mind. I'm sure there are many more.

STATE CHAPLAIN FR. JOHN LIST

"Blessed are the poor in spirit... Blessed are they who are persecuted for holiness' sake..." (Matthew 5:2, 10)

I returned recently from a pilgrimage to the martyrs of Central America in El Salvador and Guatemala. Among the most well-known were Archbishop Oscar Romero, Fr. Stan Rother, the Jesuit professors at the University of Central America and the four American church women. Among the less well-known were the tens of thousands of common, mostly poor folk who dared to dream for a better way of life or to speak out against authoritarian regimes.

Our guides, Maryknoll missioners who had personal experience of ministry in El Salvador and Guatemala, took pains to explain the complicated nature of the witness/involvement of the Church during those troubled times. The recognition of Archbishop Romero's death as a martyrdom, for example, was not without its opponents by some members of the Salvadoran hierarchy. The Vatican's declaration that his assassination was motivated by "odium fidei" (a hatred of the faith) has, as it were, canonized his advocacy for the poor as well as his condemnation of violent repression.

FR. JOHN CONT.

That part of St. Paul first letter to the Corinthians paired with the Beatitudes from Matthew's gospel contains the following: "God chose the weak of the world to shame the strong..." As the pervasive nature of the oppression of the "lowly and despised of" El Salvador and Guatemala became clear to me, it was that martyrdom of the people that took my breath away. And it was their faith in the face of persecution, their confidence in the Gospel message of their dignity as sons and daughters of their heavenly Father in Cristo Rey that was their hope and my consolation.

It challenges me to the core: where do I find my security? In whom do I trust? What challenges would I be willing to face?

January 2023-Kentucky State Per Capita Billing Update

The January 2023 KY Knights of Columbus State Per Capita bills were emailed to local councils on January 7, 2023. As of January 31st, I have received payment from 54 of 99 Councils (55%-Thanks-Great Job!). I will be sending reminders out to those councils who have not responded with payment or acknowledgement that the statement was received by their council. If any council feels they need help with anything, please contact the State Deputy or any State Officer. The assessment must be paid by **April 10** to avoid being denied delegate representation at the May 2023 KY State Convention.

"What does the Knights of Columbus KY State Secretary do?"

In the February 2022 issue of the Kentucky State Council Newsletter, I wrote on "What does the Knights of Columbus KY State Treasurer do?". This February I will write a little on what the State Secretary job duties are.

The State Secretary functions much like the Financial Secretary of the local councils. Any KY State Council funds, receipts, and bills flow through the State Secretary. The State Secretary receipts any funds received and creates vouchers to pay bills which is sent to the State Deputy for approval prior to payment by the State Treasurer. The State Secretary creates funds remitted documents to go with any checks or monies received. He then gives to the State Treasurer those remitted funds who deposits to the State Council's bank account.

During the fraternal year, a general list of the duties as State Secretary, include: **Mid-Late July**- have the finalized State Council Organizational Meeting reimbursement voucher approved and in the hands of the State Treasurer. This list will include newly elected State Officers, Past State Deputies, and appointed Committee Chairman who attended the Organization meeting earlier in the month. (Supreme is responsible for reimbursement to District Deputies who attended)

Early August- Attend the Supreme Convention as an Insurance Representative Delegate.

Mid-August- Remind the State Treasurer about submission of documents needed for the Fraternal Year (that ended June 30) CPA audit and filing of State Council Tax Form 990 per guidelines submitted by Supreme.

Mid-September -Attend State Regional sessions as scheduled, be prepared to explain the State Per Capita Billing to any new GK and FS. Record participants in attendance at the sessions as well as to maintain and process a reimbursement voucher for each session.

Mid November- Prepare for Mid-Year Meeting in early December by updating Roll Call roster. This list will include State Officers, District Deputies, Past State Deputies that attended, and appointed Committee Chairman who were invited.

Mid-December- Have the finalized Mid-Year reimbursement voucher approved and in the hands of the State Treasurer. This list will include State Officers, Past State Deputies, and appointed Committee Chairman who attended the Mid-Year meeting earlier in the month. (Supreme is responsible for reimbursement to District Deputies who attended)

Early January- Download the January 1 Kentucky local Council Rosters from Supreme for use in the State Per Capita billing process.

Early January- Use the KY State Database program to generate the Annual KY State Per Capita billing statements to local councils.

Early-Mid January- Email the KY State Per Capita statements to the councils as listed in the KY State Directory (The State Executive Secretary maintains the Directory). Statements are required according to the KY State Bylaws to be submitted to each Council by February 10 of each year.

Mid-January- Request the following information from the previous Calendar Year for the KY State Council Annual Fraternal Survey form 1728 from:

KY Association for Person with Intellectual Disabilities (KAPID) Treasurer, Knights of Columbus KY State Charities, INC Treasurer, and the KY State Treasurer that includes "Charitable Disbursements" and "Hours of Service" from:

- Family Activities
- · Community Activities
- Life Activities
- Meetings
- Other Fraternal Commitments

Mid-Late January- Compile the above charitable disbursements and hours of service information along with KY State Officer input of their fraternal activities and file the KY State Council Annual Fraternal Survey form 1728 with Supreme which is due on January 31.

Late January-Early February- Work with the State Deputy and State Treasurer to develop the upcoming Fraternal year budget.

Early March- Send the Delegate Registration letter and form to District Deputies and Grand Knights across the state for the May Kentucky Knights of Columbus State Convention.

Mid-March- Pull together the previous year's State Convention Minutes for publication in the Convention Materials. Ensure the publication is ready for distribution at the State Convention.

Late March-Send reminder emails to GK, FS, and or DD's of unpaid bills and/or physically mail Bills.

Early-Mid April- Finalize State Secretary State Convention requirements:

- Roll Call excel file.
- · Council Delegate Check-in excel spreadsheet,
- · Credentials excel file,
- State Deputy Introduction Speech.
- · Annual Report including Resolution and Candidacy Declarations
- Mid May- State Convention...Take good notes and be prepared for anything.
 Responsible to have the "Notice of Election of Officers" form and a "Supreme
 Council Representatives" form filled out immediately after the State Convention
 and submitted to Supreme ASAP.

Late May- Have the finalized State Convention reimbursement voucher approved and in the hands of the State Treasurer. This list will include newly elected State

Officers, new or returning District Deputies, Past State Deputies, appointed Committee Chairman, and certified Delegates (or Alternates) who attended the Convention.

Early June-Assemble Roll Call for the Organizational Meeting in early July. This list will include newly elected State Officers, new or returning District Deputies, Past State Deputies, and appointed Committee Chairman.

The State Secretary also attends exemplifications, Vocation Appreciation Dinners, Council meetings and other events with other State Officers.

KY State Convention Delegate Certification (COMING SOON)

Delegate Certification Forms for the 2023 State Convention to be held May 19th, 20th & 21st in Frankfort, KY will be sent to District Deputies SOON.

It is the District Deputy's responsibility to ensure that each of his councils have sufficient time to complete and return the forms by the established deadline. The forms must be completed and distributed as specified in Article I of the KY State Bylaws. Each Council is to submit one copy of the completed Delegate Certification Form to the District Deputy, retain one copy for their records and send one form to the State Secretary to arrive **no later than May 13th, 2023**.

In the event duly elected Delegates are unable to attend meetings; Alternates whose names are stated hereon will be recognized. I look forward to seeing many of you in May!

Brothers Knights, Changing Seasons!

Liturgical Seasons, that is. We've moved from Christmas to Ordinary time (did you know that Ordinary doesn't mean common – it comes from the weeks being numbered, or "ordinal") and only three weeks to Ash Wednesday and Lent. I know many of us look forward to Lent - it really doesn't count as a sacrifice not to eat meat on Fridays when Fish Frys are the high point of the season. I look forward to Lent, I need Lent, to give me a time of reflection, a chance to refresh my outlook and set new goals to help me strengthen my faith (but I look forward to the Fish Frys, too!). I encourage you to take the time to attend the Stations of the Cross at least once this year.

I mentioned last month that Suzanne and I recently celebrated our 50th Anniversary. Someone asked me what the secret is. One of the things I told him is don't die!

I bring that up because I looked at the Master Roster of members of our active councils that State Secretary Luke Williams used to generate our 2023 State Per Capita assessments recently and here's some interesting information. Of our 10,542 active members

- 25 are over 100 years old! God Bless them, and I hope they have a great quality of life and have set a great example in their lives.
- 3% are over 90
- 13% are over 80
- 33% are over 70

BURNS CONT.

- 59% are over 60
- 77% are over 50
- Only 12% are under 40

Our average age is about 63.5. The average age for an American male is 49.1. We're "timing out" faster than we should because we're not recruiting new younger members. For some of our councils this is a critical issue.

Worse yet, over halfway through the Fraternal Year. More than 40 councils have still not recruited any new members yet.

Clearly, this is not sustainable. We can't fulfill Blessed Fr. McGivney's vision of helping Catholic men to preserve their faith and protect their families if we don't invite them to join our ranks.

I challenge all of you who haven't asked a Catholic friend or fellow parishioner to ask at least one by the end of the Fraternal Year.

Whether or not your Council has a church drive, you can and should be asking Catholic men to join the order and take advantage of being a member of the Knights of Columbus. I'm sure you know men at church who aren't members and who could benefit from it (hint: every Catholic man will benefit from being a Knight!).

If each Knight asks 4 men a year to join the Order, and only one of them says yes, you'll still double the size of your council. If you don't ask, you don't grow!

Worthy Brothers, **2023 Resolutions**

I have sent each Grand Knight a Memo a second reminded them that it is time, if you are considering a submission, review, and formal voting of Resolutions, at the upcoming State Convention in May of 2023. All Resolutions have to be submitted by March 15th, to the State Advocate, with copies to the State Deputy and State Secretary. At the State Convention, delegates assigned to the Resolution Committee will review them and make recommendations to all the Delegates at the Business Meeting. Each Resolution will be open for discussion and voted upon. The Resolutions that deal with matters beyond our Jurisdiction will be submitted to the Supreme Advocate for consideration at the Supreme Convention. DD Tim Molnar knows how this works as he submitted a Resolution that created a Form 1831 for brothers that are disabled.

Council Forms!!

It is time to Submit Form 1295 Semiannual Council Audit Report. This is for the period ending December 31st and is due February 15th.

It is also time for **Form 1728 Annual Survey of Fraternal Activity**. This is for the calendar year 2022 and is due January 31st. this help publicize the considerable contributions of your councils and also helps maintain status as a charitable organization.

I hope all councils have submitted Affiliated Membership roster. This is a way to transfer your inactive Brothers, and save your council Supreme and State assessments.

Safe Environment Training

The "Safe Environment Training" is at 28 councils are fully Compliant. Many Councils have just one more Brother to be Compliant. If you need help, please call me or e-mail me.

We need to achieve our "Safe Environment Training" goals, which is 36 councils. This means, Grand Knight, Program Director, Family Director, and Community Director need to complete the training. If you have completed this training in the last three years, you are good to go. It is on line training and takes about an hour to complete. Please watch for an e-mail from "Armatus" for this training, also watch your spam folder. Once you have completed this training, make sure you print the certificate. This is a requirement for Star Council.

Councils that sponsor youth events (Free Throw Competitions, Soccer Challenge, Keep Christ in Christmas Poster, eta) "Safe Environment Training" (SET) is a must. You must have at least two SET Knights at these events (one must have a background check). If you cannot meet this requirement, you should not conduct this event. The same requirement is for youth helping you in your events (Fish fries, chicken cooks).

Recruit and Retain

A another recruiting event is coming soon, Fish Fries for Lent, starting Ash Wednesday, February 22. Ask the Families, the Men, coming through the line to join us. A new member can join on his iPhone and transfer into your council. Just go to www.KofC.Org. The new **Promo Code BLESSEDMCGIVNEY**. The new Young Members and Families have the Best Ideas and know some of best practices.
