

One of the best parts of the weekend was seeing the friendships that are developing. More than once I was thanked for hosting the monthly Zoom meetings with the DDs & GKs. Those meetings enabled men from across the state to get to know each virtually and then to meet in person.

#### **State Deputy's Report:**

As of May 1st, we have added 325 new members to the State Council. We need 132 to meet our goal.

There are still 25 councils that have not recruited a new member. For some it's been over two years without recruiting.

There are 46 councils that could achieve Star Council if they want it. Eight councils have already achieved Star Council with a couple achieving Double Star.

The next FBE will be on May 22nd at 7:00pm EDT. Don't miss this opportunity. I believe that there will only be one more on-line event. GKs, you'll need to fill out form 11077 after each event.

Don't forget to fill out and turn in form 10784 whenever you or your council has an event of any magnitude. Many more of you could have received either Program Director or State Deputy award.

## STATE CHAPLAIN FR. JOHN LIST

"Whoever remains in me, and I in him, will bear much fruit..." John 15:5

As we continue in the unfolding of the Easter season, we have the opportunity to reflect more deeply on the meaning of the Paschal mystery. The document of the US bishops on The Mystery of the Eucharist in the Life of the Church has this to say: "The salvation offered in the Life, Death, and Resurrection of Christ is nothing less than sharing in the very life of God, in the communion of love among the Father, the Son, and the Holy Spirit. There is no greater gift that God could possibly give us. In Christ, we are sharers in the divine nature (2 Pt 1:4). The Church Fathers referred to this participation in the divine life as 'divinization.' The eternal Son of God made this possible by becoming man and uniting humanity to his divine Person. St. Augustine explained, 'the maker of man was made man, so that man might be a receiver of God.' In fact, Pope Francis reminds us that 'in the bread of the Eucharist, "creation is projected towards divinization, towards the holy wedding feast, towards unification with the Creator himself.""

Two years ago, a three-year program of Eucharistic revival began. This year it will culminate with a National Eucharistic Congress on July 17 to 21 in Indianapolis, IN. My schedule will not allow me to attend the Congress itself, what with mission appeals, etc., and perhaps your busier than expected summer may also keep you from getting to Indianapolis as well. But here's an ideabefore the Congress convenes, a pilgrimage with the Blessed Eucharist is coming through the Diocese of Owensboro and the Archdiocese of Louisville on the way to Indianapolis. On June 30th the Juan Diego branch of the pilgrimage enters Franklin, KY, and continues over the next couple of days through Russellville and Auburn to arrive in Bowling Green on July 3rd. On July 4th the pilgrimage will begin its journey through the Archdiocese of Louisville at St. Catherine's in New Haven and then move on to spend the night at Gethsemane. The next day the journey

continues to Loretto and Nerinx, then St. Catherine and Springfield on the 6th with a full day at multiple locations in Bardstown on the 7th. The Kentucky portion of the Juan Diego leg of the pilgrimage allows for two days of visits to multiple churches in Louisville.

I'm thinking an afternoon with the Lord in the Blessed Eucharist at the Abbey of Gethsemane sounds like a pretty good way to spend the 4th of July.

Here are items that should be on all Councils and District Deputies checklist to consider/complete for May and June.

- The Report of Officers Chosen (#185) is due by June 30th. This can be easily completed by the Financial Secretary in the Member Management software or can still be filled out and sent in. Please make sure a copy is sent to the State Deputy and your District Deputy.
- RSVP Applications (Supreme Form #2871) for \$100 refunds for Councils giving at least \$500 in support of a seminarian or novice are due at Supreme between April 1st and June 30th.
- After the upcoming Elections, Council Officer information needs to be sent to the KY State Executive Secretary for the State's records. Any changes to Council meeting location or time also should be sent to the State Executive Secretary.
- Prepare the Councils Columbian Award Application (#SP-7) and have the State
  Program Director review before sending a final copy to the Supreme Council office
  before the June 30th deadline. Your State Program Director is a great resource to
  help with this report. This document is a great tool for future Council Officers to be
  able to review all the activities done by the Council (large or small) to help with their
  Goals and Calendar for upcoming Fraternal Years to come.
- A review of the 2023-2024 fraternal year initiatives and activities should be done to see what worked and if any improvements can be made. This review is a great resource for years to come.
- The Grand Knight should fill out the Service Program Personnel Report (#365) and turn into the Supreme Office and the State Deputy by August 1st.

- The Installation of Council Officers should be scheduled.
- Congratulations to those Councils who have already completed the requirements for the "Star Council Award". I commend you for your dedication and work.
- Always ask someone to join your council or our ranks as Catholic Gentlemen.

Our Supreme Knight Patrick Kelly asks all Knights to ask at least one man to join the Knights before June 30, 2024. One of the first steps is to schedule at least One Exemplification before June 30 and work towards that date. Good Luck

- ~260 more tickets sold this year from last year
- The Disaster Relief Fund benefits areas inside and outside the state that experience natural disasters.

As the years go by, we spend less and less time cleaning the car and dirt starts to accumulate, mostly in areas no one can see. Ultimately, the car dies, and we move on. The car ends up in a junkyard with dirt clinging to it.

For me, I see the life of a new car as a metaphor for our lives. When we are born, we are pure of heart, clean and shiny, except for the "Original Sin" imposed by God. But, when we welcome a newborn into the world, we don't see the "Original Sin." We try to keep our hearts clean. After being baptized, we go to Confession regularly to cleanse our hearts, but there's not much we can do about that pesky "Original Sin." But, no problem, it still can't be seen.

As the years go by, many of us oscillate on Confessions. We don't go as often as we used to or admit to as much sin. Ultimately, we die, with some dirt clinging to us. But the "Original Sin" is gone because the price for "Original Sin" is death.

Good News! Unlike cars, we have the power of "intercessory prayer." The Penitential Act. A Prayer so powerful that it is often used at the beginning of every Mass to cleanse us of Sin before entering the presence of God.

One of the most important ways Knights of Columbus support each other is through prayer, especially at the time of death. Brother Knights demonstrate their fraternity in exemplary measure when they pray for the soul of a departed Knight and console the members of his family. In this regard, the Knights have continued the venerable tradition of praying the Rosary during the wake of a departed brother. In order to facilitate this a Knights of Columbus Memorial Service has been developed for use throughout the Order. All councils and assemblies are urged to use this service as they pray at the wakes of the brother knights.

### CARTER CONT.

Without exception, honors by the Honor Guard shall be offered to deceased Sir Knights, their immediate family members, Council members and to their immediate family members provided a request is made. It must be distinctly understood that the wishes of the family of the deceased member are paramount and will be given the fullest consideration as to the selection of elements of the Honor Guard involved.

It is noticeable that providing this service for brother knights is not offered a much now days as it was nearly ten years ago before the uniform change. I'm not sure but it seems no one actually paid attention to the protocol.

While the "Old Regalia" and the "New Uniform" cannot coexist in the same ceremony, the ceremony can still be performed so long as everyone is wearing either the new uniform or everyone is wearing a tuxedo with the social baldric. Please do not let a change in uniform interfere with your view of what is right and proper for our brothers' departure from this world.

#### **Protecting Your Greatest Asset**

Spring is here, we have a new season and after a blessed Easter it's time to start planning again. With spring and the break in the weather, I've started to put together my honey-do list that will take me outside into the sunshine. I don't know about you, but this time of year seems to energize me. After being cooped up all winter, and this year really being cooped up, I've been able to think of all the things I need to get done.

Now when you get outside to get that work done, please be careful! I'm reminded of two acquaintances who were recently up on ladders. In both cases, the ladder slipped, and each gentleman sustained two broken arms! Out of commission for quite a while. But there are many hazards that can put you out of commission...and that brings me to the important part of my message this month. Protecting your greatest asset!

Your greatest asset is your ability to work and earn an income! Take your annual income (probably fresh in your mind with tax filing day) and multiply it times your remaining years of working. A 35-year-old male making \$50,000 a year will earn \$1.5 million in the next 30 years.... if he never gets another raise! So, you have an income to protect. But what if you're sick or hurt and can't work. Maybe it's something simple like the gents above...a set of broken arms.

Disability does not discriminate; man or woman; black, white, Hispanic, or Asian; young or old. A 2014 CDA Long-Term Disability Claims Review had several notes: More than 1 in 4 of today's 20-year-olds will become disabled before they retire, 76% of Americans live paycheck to paycheck; less than 5% of all disabling accidents and illnesses are work

related. That means 95% of those are not covered by Worker's Compensation. You're on your own 95% of the time. Turn to Social Security; but Social Security's report on SSDI says that only about 40% of applicants are awarded benefits. Couple that with 69% of the private sector workforce having no long-term disability income insurance and it's no wonder disabilities are the #1 cause of mortgage foreclosures.

So, what to do? Plan a meeting with your K of C Field Agent. Do you need disability income insurance? If so, how much? Let's plan for the worst...but expect the best. We can't see what the future will bring, our Field Agents are here to help you plan for the unexpected. Meanwhile, stay safe and healthy.
